hereby solemnly and sincerely affirm and state as follows:

1. I submit that I am the 1st petitioner herein and as such I am well acquainted with the facts of the case. I am filing this Affidavit on behalf of other petitioners as well.

2. It is respectfully submitted that the Petitioner is filing the present contempt case aggrieved by utter disobedience shown by the respondents i.e., the contemnors herein. The brief facts of the case is as follows:

3. It is submitted that the Petitioner filed a Writ Petition No. 8136 OF 2025 before the Hon'ble A.P. High Court at Amaravathi seeking the following relief:

"to issue Writ or Order or Direction more particularly in the Writ of Mandamus by declaring the inaction of the respondents in not taking legal action against the encrochers i.e. the 5th and 6th respondent from unauthorised occupation of the Akhila Bharatha Srisaila Kshetra Vadiyarajula Satram at Srisalem is illegal which is in the control and administration of the 4th respondent of the Srisaila Kshetra Devasthanam dated 29.12.2024 is illegal, unjust, arbitrary and against the provisions of the Act and violative of Article 19 and 21 of the Constitution of India and to consequently to direct the respondents 3 and 4 to take steps for the respondents 5 and 6 to protect the endowment property and to enable the petitioners to run the Vadiyarajula Socety as per the by-laws of the society"

4. It is further submitted that after hearing the arguments of both sides, the Hon'ble A.P. High Court has disposed of the W.P. No. 8136 of 2025 on 03.04.2025 with the following observation and direction:

"By following the above said order, the writ petition is disposed off with a direction to the respondents to complete the enquiry within a period of two months from the date of receipt of the copy of the order. Needless to observe

sufficient opportunity for hearing must to the petitioner. There shall be no order as to costs."

5. It is further submitted that after receipt of the Order of the Hon'ble A.P. High Court dated 03.04.2025 passed in W.P. No. 8136 of 2025, the Petitioner submitted representation dated 20.06.2025 to the respondents by duly enclosing the copy of the Order seeking for conducting enquiry by giving opportunity to the petitioner within two months. But the respondent did not consider my representation dated 20.06.2025 and failed to conduct enquiry by giving me opportunity of hearing and dispose the same within two months by duly implemented the orders of the Hon'ble A.P. High Court in W.P. No. 8136 of 2025 for the reasons best known to them.

6. It is further submitted that for the due implementation of the Hon'ble A.P. High Court order in W.P. No. 8136 of 2025, the respondent did not consider my representation to conduct enquiry by giving an opportunity for hearing.

7. It is further submitted that the Petitioner gave representation dated 20.06.2025 along with enclose of order copy and personally visited the respondent office for the due implementation of the order passed by the Hon'ble A.P. High Court in W.P. No. 8136 /2025. But there was no action on the part of the respondent to conduct enquiry Even after a lapse of more than lapse of more than two months from the date of order passed in W.P. No. 8136 of 2025, the Petitioner's request for conducting of enquiry was not implemented by the respondent authorities even after the passing of the Order by the Hon'ble A.P. High Court and the representation from the Petitioner.

8. It is humbly submitted that at any rate the non-implementation of the directions of the Hon'ble A.P. High Court amounts to clear ex-facie, deliberate, intentional, willful, disobedience of the Hon'ble Court and honor besides

violating the rights of the Petitioner and therefore it is humbly prayed to take cognizance of the same for the said contempt committed by the Respondents in accordance with the provisions of contempt of Courts Act r/w Article 215 of Constitution of India. Hence, the Contempt Case. the respondents had wantonly and deliberately violated the orders of this Hon'ble court and disobeyed the orders of this Hon'ble court and thereby committed contempt of order of this Hon'ble court. The respondents had rendered themselves liable for punishment under section 10 to 12 of the Contempt Courts Act, 1971.

Hence this Hon'ble court may be pleased to issue summons to the Respondents upon due enquiry may be pleased to punish the Respondent under section 10 to 12 of Contempt of Courts Act, 1971, for their wilful disobedience of order dated 03.04.2025 passed in Writ Petition No 8136 of 2025 on the file of this Hon'ble court and pass such other orders as this Hon'ble court may deem fit and proper in the circumstances of the case.

The present writ petition is filed challenging the inaction of the respondent in not taking action against the encroachers i.e., the 5th and 6th respondent from unauthorized occupation of the premises of Akhila Bharatha Srisaila Kshetra Vadiyarajula Satram, Srisailam.

2. Heard Sri P.Srinivasulu, learned counsel for the petitioner and Sri T.Venu Gopal, learned Standing Counsel for Endowments. With the consent of both the learned counsel the writ petition is disposed of at the stage of admission.
3. Today, when the matter is taken up for admission, learned Standing Counsel for Endowments, has placed on record a copy of the written instructions received from the 4th respondent, dated 02.04.2025. A perusal of the same would reflect that their office has received multiple complaints against the Akhila Bharatha Srisaila Kshetra Vadiyarajula Satram, Srisailam, regarding mismanagement, non production of accounts, and non-conduct of annual audits. An inquiry was initiated, and notices were issued to the Committee to attend for inquiry on 07.01.2025 and 17.01.2025, with relevant records.
4. However, the Committee has requested to reschedule the inquiry to 05.02.2025, on account of sickness of the Chairman and the enquiry could not be concluded.
5. The written instructions of the 4th respondent, dated 02.04.2025 are placed on record.
6. Having regard to the same, since the inquiry has already been initiated, this Court does not deem it fit to issue a writ to the respondents.
7. Accordingly, the Writ Petition is disposed of with a direction to the respondents to complete the inquiry within a period of two months from the

date of receipt of the copy of the order. Needless to observe, sufficient opportunity for hearing must to the petitioner. No costs.

As a sequel, all pending miscellaneous applications shall stand closed.

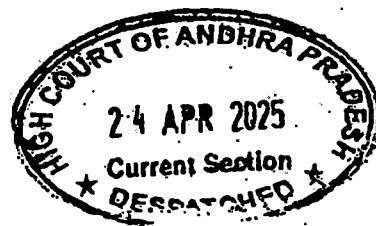

I, Pallapu. Srinivasulu, S/o Venkateshwarulu, aged about 51 years, President of Akhila Bharatha Srisaila kshetra Vadiyarajula Satram Srisailam, R/o Puchakayalapalli Village & Post, Peddaaraveedu Mandal, Prakasam District, Andhra Pradesh, now having temporarily come down to Amaravati, do hereby solemnly and sincerely affirm and state as follows:

1 I submit that I am the 1ST Petitioner herein and as such I am well acquainted with the facts of the case. I am filing this affidavit on behalf of other petitioners as well.

2. I further submit I that since the cause of action of all the petitioners herein is one and the same, we are filing a single writ petition. However, as required under writ rules, separate court fee is paid herewith.

3. I submit that we have filed this Writ petition seeking for the relief of declaring the inaction of the respondents in not taking legal action against the encrochers i.e. the 5th and 6th respondent from unauthorised occupation of the Akhila Bharatha Srisaila Kshetra Vadiyarajula Satram.

at Srisalem is illegal which is in the control and administration of the 4th respondent of the Srisaila Kshetra Devasthanam dated 29.12.2024 is illegal, unjust , arbitrary and against the provisions of the Act and violative of Article 19 and 21 of the Constitution of India.

4. It is submitted that the 1st petitioner is the president and the 2nd petitioner is treasurer and 3rd petitioner is executive committee member of the Akhila Bharatha Srisaila kshetra Vadiyarajula Satram, Srisailam. The sangham is registered under the Society Act under the registration number 17/1975 which was renewed from time to time as per the By laws of the society. The object of the Sangham is to do welfare activities and to render service to the devotees of Vadiyarajula community who visit Srisaila kshetram for offering prayers. The committee by collecting donations constructed Annadhana Satram, Kalyana mandapam and New Rooms to give accomodations to the devotees. As per the by laws of the society election used to be held for every three years. The satram is under the control and administration of the 3rd respondent.

5. It is submitted that in the year 2019 and also in the year 2022 the petitioner is elected as the president of the Sangham and as per the by laws run the sangham. In the general body meeting it was decided to construct new rooms for the satram and also a Kalyana mandapam.

The petitioner sagham collected donation amounts from the devotees. The 6th respondents also used to donate the material required for constuction and interior works of the Satram. The 6th respondent is the resident of State of Telangana. The 6th respondent is noway concern with the administration activites of the socity .

6. It is submitted that the petitioners committee decieded to open the Kalyana Mandapam and New rooms on 26.04.2023. The petitioner sent invitations to the all the donors inclunding the respondent 6 and 7 through donated rooms and kalyana mandapam in satram. The 6th respondent with a malafide intention entered in took over the satram office and took over the records and books and occupying the satram premises by illegally taking control of the administration of the satram. As per the bylaws the tenure of the executive body is upto the year 2025 . The respondents 5 and 6 is illegally forcefully restrained the petitioners from discharging their duties.

7. It is submitted the petitioners and other executive members gave representations to the respondents authorities to conduct enquiry and gave representations dated 11.11.2023 and 29.12.2024 to take actions against the respondents 5 and 6. The respondents 5 and 6 illegal acts of the 5 and 6 to evict them for unlawful occupation from endowment property. The respondent 5 and 6 tring to misappropriate the funds of the society and unauthorized occupied the endowment property. The

respondent 3 and 4 failed to take steps against 5 and 6 to evict them from the schedule property.

8. It is submitted that the Section 85 of AP Charitable and Hindu Religious Institution and Endowment Act, 1987 prescribes Encroachment on persons by land or building belong to charitable or religious institution or endowment and the eviction of encroachers :-

i) Where the Assistant Commissioner having jurisdiction, either suo motu or upon a complaint made by the trustee has reason to believe that any person has encroached upon (hereinafter in this Chapter referred to as encroacher) any land, building, tank, well, spring or water-course or any space belonging to the institution or endowment, wherever situated or deemed as an encroacher under any of the provisions of this Act the Assistant Commissioner shall report the fact together with relevant particulars to the (Endowment) having jurisdiction over the division in which the institution or endowment is situated.

ii) Prayer on report on received by him finds that there are prima facie face of encroachment shall cause to serve upon encroachment notice.

iii) The notice -----

iv) While after considering the objections the deputy commissioner has satisfied there has been encroachment order to remove the encroachment.

Section 84 Mode of eviction on failure of removal of encroachment –

i) where within the period specified in order of Sub section 4 of 83 the encroacher has not removed from not rotated the land the assistant commissioner by remove the encroachment and obtain possession of the land.

9. It is submitted that the Sangham is the part of the Srisaila Devasthanam and the sanghamis in the control and administration of the Devasthanam. The 4th respondent used to consider the application of the Akhila Bharatha Srisaila Kshethra Vadiyarajula Satram committee and also grant permissions for the construction of rooms, water towers and Kalyana Mandapam's for the community devotees.

In the circumstances stated above, the petitioner has no efficacious alternative remedy, except to seek the redressal before this Hon'ble Court seeking the indulgence of this Hon'ble Court to exercise the extraordinary original jurisdiction vested in this Hon'ble Court by virtue of Article 226 of the Constitution of India.

The petitioner has not filed any writ petition, suit or other proceedings for the relief or relieves sought herein.

It is therefore prayed that this Hon'ble Court may be pleased to issue Writ or Order or Direction more particularly in the Writ of Mandamus by declaring the inaction of the respondents in not taking legal action against the encroachers i.e. the 5th and 6th respondent from unauthorised

occupation of the Akhila Bharatha Srisaila Kshetra Vadiyarajula Satram at Srisalem is illegal which is in the control and administration of the 4th respondent of the Srisaila Kshetra Devasthanam dated 29.12.2024 is illegal, unjust, arbitrary and against the provisions of the Act and violative of Article 19 and 21 of the Constitution of India and to consequently to direct the respondents 3 and 4 to take steps for the respondents 5 and 6 to protect the endowment property and to enable the petitioners to run the Vadiyarajula Society as per the by-laws of the society and pass such other order or orders may deem fit and proper in the circumstances of the case.

It is also just and necessary that this Hon'ble Court may be pleased to pass urgent orders by directing the 4th respondent to consider the representations dated 29.12.2024 to take legal steps for eviction of respondent for 5 and 6 from encroachment of property Akhila Bharatha Srisaila Kshetra Vadiyarajula Satram at Srisalem and pass such other order or orders may deem fit and proper in the circumstances of the case.

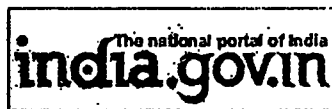

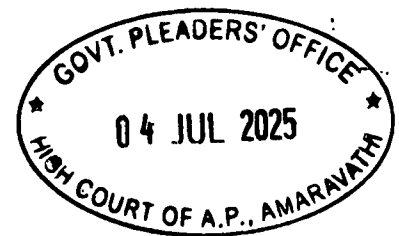
