**AFFIDAVIT**

I, V.V.S Ganapathi, S/o V. Ranganna, aged about 54 years, Occ: Junior Assistant, R/o D.No. 2-3-149, MIG Staff Quarters, Srisailam, Kurnool District, temporarily come down to Vijayawada, do hereby solemnly affirm and sincerely state on oath as follows:

1. I submit that, I am the 1<sup>st</sup> petitioner in the writ petition as well as in the present contempt case and deponent herein and as such I am well acquainted with the facts of the case. I am authorized to depose on behalf of the other respondents also.
2. It is submitted that the writ petition is filed challenging the action of the 2<sup>nd</sup> respondent in issuing the proceedings in Rc. No.C1/13025(43)/40/2025-1, dated 09-06-2025 transferring the petitioners from 3<sup>rd</sup> respondent temple to 4<sup>th</sup> respondent temple as bad, illegal, arbitrary and violative of A.P. Charitable Hindu Religious Institutions and Endowments Transfer of Office Holders and Service Rules 2020, without jurisdiction, violative of principles of natural justice and violative of Articles 14, 16 & 21 of Constitution of India.

3. I submit that, this Hon'ble court on 23.06.2025 has passed the interim orders and suspended the impugned transfer orders dated 09.06.2025 and the operative portion of the order is extracted hereunder for kind perusal of this Hon'ble court:

***"Learned counsel for petitioner submits that in identical circumstances, this Court in W.P. No.19386 of 2022 passed interim order suspending the transfer orders, considering the fact that employees who were appointed prior to 08.12.2000 being governed by the Rules framed under G.O.Ms.No.1478, dated 17.11.1986 are not susceptible for transfer under the later Rules, inasmuch as even in the present case, all petitioners have been appointed prior to 08.12.2000 under earlier Rules, petitioners are entitled to be extended similar benefit.***

***In view of the same, having regard to the fact that this Court has already considered the similar case in No.19386 of 2022, which later came to be followed in W.P. No.21685 of 2022, there shall be interim suspension as provided for pending further orders."***

4. I submit that, immediately thereafter we have submitted a representation on 25.06.2025 by enclosing a web copy of the order dated 23.06.2025 of this Hon'ble court requesting them to reinstate us in the Sri Bramaramba Mallikarjuna Swamyvarla Devasthanam, Srisailam, Nandyal District and further allow us to render duties since the impugned transfer orders are suspended in

the light of the orders passed by this Hon'ble court dated 23.06.2025.

5. I submit that, thereafter we came to know that the 2<sup>nd</sup> respondent has submitted a detailed report on 27.06.2025 in pursuance of the instructions of the 1<sup>st</sup> respondent requesting the 1<sup>st</sup> respondent issue suitable joining orders for us. Thereafter the matter came to a stand still position instead of complying the orders the 1<sup>st</sup> respondent has issued Memo dated 18.07.2025 directing the E.O to file counter and Vacate Stay petition, as on today the same is not filed. Earlier when the similar issue came up the 1<sup>st</sup> respondent has issued orders dated 28.10.2024 and they were reinstated but different approach is taken in the instant case and we are discriminated.
6. I submit that, till date no action is taken and we all are kept in air and the respondent authorities are not reinstating us and the orders of this Hon'ble court dated 23.06.2025 are not complied till date. Further we were made to run from pillar to post however no positive action despite there being orders from this Hon'ble court. As such we are constrained to file the present contempt case.
7. I submit that, the action of the respondents is not only arbitrary but amounts to clear violation of the orders of this Hon'ble Court. The respondents despite being aware of the interim direction, have deliberately chosen to contravene the

same. This act of the respondents clearly establishes that they are willfully flouting the orders of this Hon'ble Court. Hence the present contempt case.

8. I submit that the respondent does not have any respect towards the orders of this Hon'ble Court and they are willfully and wantonly violating the orders, as such they are liable for punishment under the Contempt of Courts Act.

It is therefore prayed, that this Hon'ble Court may be pleased to punish the respondent under Sections 10 to 12 of The Contempt of Courts Act, 1971 for willful violation and disobedience of the orders of this Hon'ble Court passed in W.P No. 14325 of 2025 dated 23.06.2025 and pass such other order or orders as this Hon'ble Court may deem fit and proper in the circumstances of the case.

1. I submit that, I am the 1<sup>st</sup> petitioner and deponent herein, as such I am well acquainted with the facts of the case. I am authorized to depose on behalf of other petitioners herein also.
2. It is submitted that the present writ petition is filed challenging the action of the 2<sup>nd</sup> respondent in issuing the proceedings in Rc. No.C1/13025(43)/40/2025-1, dated 09-06-2025 transferring the petitioners from 3<sup>rd</sup> respondent temple to 4<sup>th</sup> respondent temple as bad, illegal, arbitrary and violative of A.P. Charitable Hindu Religious Institutions and Endowments Transfer of Office Holders and Service Rules 2020, without jurisdiction, violative of principles of natural justice and violative of Articles 14, 16 & 21 of Constitution of India.

3. I submit that the following are the details of the service particulars of the petitioners and their cadres:

4. I submit that, we are all appointed in the 3<sup>rd</sup> respondent institution on the above said dates and in various cadres. Thereafter promotions were effected to us and at present in the cadres as mentioned above without any blemish.
5. I submit that, while the matter stood thus, the Govt. has lifted the ban on transfers and during the general transfers, on 15.05.2025 and we all were transferred to the 4<sup>th</sup> respondent institution as per the impugned proceedings of the 2<sup>nd</sup> respondent issued on 09.06.2025 and consequentially relieved on 10.06.2025, however we have not joined at the transferee station and as per our knowledge our posts in the 3<sup>rd</sup> respondent temple were also not filled up till date.
6. I submit that, the Government has framed Temple Employees Transfer Rules namely A.P. Charitable Hindu Religious Institutions and Endowments Transfer of Office Holders and Service Rules 2020 vide G.O. Ms.301 dated 12-10-2020. As per the said rules, transfers of the Temple employees' terms and conditions were

prescribed. As per the said Rules there are certain exemptions for transfers and they are extracted hereunder for the kind perusal.

- i) As per Rule 4 (iii), there shall not be any transfer or deputation from or to any 6(c) institutions;
- ii) As per Rule 5 no person shall be transferred within a period of three years;
- iii) As per Rule 5-2<sup>nd</sup> proviso, that only employees who are appointed in the sanctioned posts as per the Rules framed in G.O. Ms.888 dated 8-12-2000 are entitled for transfer;
- iv) As per Rule 6(b), no transfer shall be made during the ban period imposed by the Government;
- v) As per Rule 6(c), while effecting transfers, spouse cases, medical grounds, left over service of superannuation and mutual services and mutual transfer applications have to be considered;

7. I submit that our transfers are illegal and contrary to their own rules because:

- a). As per Rule 5 provision 3, only employees who were appointed as per Rules framed under G.O. Ms.888 dated 8-12-2000 are entitled for transfer, but coming to my case, we were not appointed as per G.O. Ms.888 dated 8-12-2000, but we were appointed prior to the said Rules on 01-12-1999 as per Rules framed under G.O. Ms.1478 dated 17-11-1986. Hence our transfer is illegal as my appointment is prior to G.O. Ms.888 dated 8-12-2000. As such the respondents do not have the jurisdiction to transfer us or relieve us.

- b). Further the G.O. Ms. 301 mentions about the spouse cases, medical grounds, left over service of superannuation and mutual services and mutual transfer applications, but none of the above reasons were sought by the 2<sup>nd</sup> respondent and straight away transfer orders were issued as per their whim and fancies. As such the same is illegal and liable to be set aside. As our cases have to be considered on humanitarian grounds and medical grounds as we have the medical background.
8. I submit that, earlier similar issue was brought up before this Hon'ble court and in the similar circumstances, this Hon'ble Court in W.P. NO.19390 of 2022 and batch has granted interim orders on 08-07-2022 observing that G.O. Ms.301 does not apply to the employees as per G.O. Ms.1478 dated 17-11-1986. We also stand in the similar footing.
9. I submit that even after joining in the new station this Hon'ble court has passed interim orders in WP No. 21685/2022 dated 12-09-2022, 2454/2023 dated 02.02.2023. As such our cases also have to be considered, as we also stand in similar footing
10. I submit that, petitioners no.1 and 2 have got medical grounds and coming to the 3<sup>rd</sup> petitioner, she is a widow, but still without considering the said aspects and without assigning any reasons transfer orders are passed, even the 1<sup>st</sup> and 2<sup>nd</sup> petitioners have also submitted representations informing the same. Hence in the circumstances stated supra unless the petitioners transfer orders

are set aside, We will be put to irreparable loss and injury and the same cannot be compensated by any means.

11. It is submitted that the petitioners have no other alternative and efficacious remedy except to approach this Hon'ble Court under Article 226 of constitution of India.
12. It is submitted that the petitioner has not filed any suit, application or petitions before any court of law and we have not sought for any similar relief.

In the above mentioned circumstances, it is therefore prayed that this Hon'ble Court may be pleased to issue an appropriate Writ order or direction more particularly, one in the nature of Writ of Mandamus, declaring the action of the 2<sup>nd</sup> respondent in issuing the proceedings in Rc. No.C1/13025(43)/40/2025-1, dated 09-06-2025 transferring the petitioners from 3<sup>rd</sup> respondent temple to 4<sup>th</sup> respondent temple and consequential relieving orders dated 10.06.2025 as bad, illegal, arbitrary and violative of A.P. Charitable Hindu Religious Institutions and Endowments Transfer of Office Holders and Service Rules 2020, without jurisdiction, violative of principles of natural justice and violative of Articles 14, 16 & 21 of Constitution of India and consequently set aside the same in respect of the petitioners transfers and pass such other order or orders, in the interest of justice.

Pending disposal of the writ petition, it is therefore prayed that this Hon'ble Court may be pleased to suspend the operation of the impugned proceedings in Rc. No.C1/13025(43)/40/2025-1, dated 09-06-2025 issued by the 2<sup>nd</sup> respondent and in transferring

petitioners from 3<sup>rd</sup> respondent temple to 4<sup>th</sup> respondent temple only in respect of the petitioners and consequential relieving orders dated 10.06.2025 and pass such other order or orders in the interest of the justice.


