



2. It is submitted that the writ petition is filed challenging the action of the respondents 2 and 3 in not paying the salaries from August 2021 to till





date as bad, Illegal, arbitrary, violative of principles of natural justice and violative of Articles 14, 16, 21 & 300A of Constitution of India.

3. I submit that the W.P was disposed of on 30-08-2024 observing as follows:

"Upon hearing the submissions of both learned counsel, this Court feels it appropriate to dispose of the writ petition by directing the respondents 2 and 3 to release the arrears of salary to the petitioner, in pursuance of the report submitted by the 3rd respondent to the 2nd respondent vide R.C.No.B2/E.No.1061452, dated 14.12.2021, within a period of three (03) months from the date of receipt of a copy of this order."

4. I submit that there after I have submitted representation on 30-12-2024 enclosing the web order copy. Thereafter the 1<sup>st</sup> respondent herein has issued Memo in Rc.No.COE-24026/2023 Dated. 11/09/2024. directing the 2<sup>nd</sup> respondent herein to release differential remuneration of Rs.625/- thereafter, I was paid an amount of Rs.25,625/- instead of paying Rs.3,20,000/- (40 months X 8000 ) as per the report of the then Assistant Commissioner Vijayawada, Dated 14-12-2021
5. I submit that the directions of this Hon'ble Court are interpreted as per their whims and fancies and the orders are flouted as such the respondents are liable for punishment under the Contempt of Courts Act; 1971.







ORDER:

The Writ Petition is filed under Article 226 of the Constitution of India,  
seeking the following relief:



*".....declaring the action of the respondents 2 and 3 in not paying the salaries from August 2021 to till date to the petitioner from Archaka Welfare Fund as bad, Illegal, arbitrary, violative of principles of natural justice and violative of Articles 14, 21, 25 and 300A of Constitution of India and consequently direct the respondents 2 and 3 to forthwith pay the arrears of salaries and continue to pay the salaries to the petitioner from Archaka Welfare Fund and pass such other order or orders....."*

2. The grievance of the petitioner is that initially he was appointed as Archaka in two temples at Vijayawada by the 3<sup>rd</sup> respondent vide proceedings in D.Dis.No.A1/3561/1999, dated 29.09.1999 on a total salary of Rs.10,500/- per month and he worked in the said two temples without any remarks from any corner. While so, he was paid the salary of Rs.8,000/- from the Archaka Welfare Fund from August 2021. As such, he made representation to the 3<sup>rd</sup> respondent seeking release of arrears from Archaka Welfare Fund. Thereafter, he made another representation to the 2<sup>nd</sup> respondent on 01.05.2022 requesting release of salary from August, 2021, who in turn, directed the 3<sup>rd</sup> respondent to submit report. But even as on today, no single paise paid to the petitioner. Hence the present writ petition came to be filed.

3. The 4<sup>th</sup> respondent has filed counter. While denying the contents of the writ petition, has submitted that, the 4<sup>th</sup> respondent has made payment of salary to the petitioner honoring the terms of payment as agreed till date and more over, the petitioner discharges duties of Archakatwam in Sri Lakshmi Narasimha Swamy Mandir, which was adopted by Sri Durga Malleswari

Swamy Varla Devasthanam, Indrakeeladri, Vijayawada and the said temple would effect payment of salary in realization of his entitlement and therefore, the petitioner is not entitled to insist upon payment of salary from Archaka Welfare Fund created in terms of Section 65A of the Endowments Act, 30/1987 and the salary of the petitioner was enhanced from time to time. In fact, the petitioner has been in receipt of Rs.27,600/- totally per month. Further submitted that Archaka Code No.12428 was assigned to the petitioner in respect of Sri Lakshmi Narasimha Swamy Mandir, as such he is entitled to payment of salary for the services rendered in the said institution only. Therefore, the 4<sup>th</sup> respondent is not liable to effect remittance of payment of salary to the petitioner. Hence sought for dismissal of the writ petition.

4. Heard learned counsel for the petitioner, learned Assistant Government Pleader for Endowments, appearing for the respondents 1 to 3 and Mrs.Padmavathi Padnavis, learned Standing Counsel, appearing for the 4<sup>th</sup> respondent.

5. Upon hearing the submissions of both learned counsel, this Court feels it appropriate to dispose of the writ petition by directing the respondents 2 and 3 to release the arrears of salary to the petitioner, in pursuance of the report submitted by the 3<sup>rd</sup> respondent to the 2<sup>nd</sup> respondent vide R.C.No.B2/E.No.1061452, dated 14.12.2021, within a period of three (03) months from the date of receipt of a copy of this order.

6. With the above observation, the Writ Petition is disposed of. There shall be no order as to costs.

As a sequel, interlocutory applications, if any pending, shall stand closed.

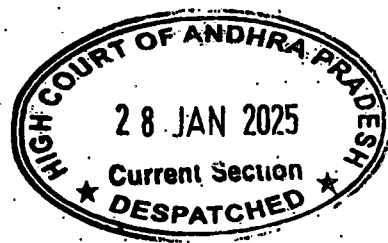





1. I am the deponent and the petitioner herein as such I am well acquainted with the facts of the case.
2. It is submitted that the present writ petition is filed challenging the action of the respondents 2 and 3 in not paying the salaries from August 2021 to till date as bad, Illegal, arbitrary, violative of principles of natural justice and violative of Articles 14, 16, 21 & 300A of Constitution of India.
3. I submit that I was appointed in the following Group Temples at Vijayawada vide proceedings of the then Assistant Commissioner, Endowments Department, Vijayawada vide proceedings in D.Dis. No.A1/3561/1999 dated 29-9-1999 and my salaries are apportioned as mentioned below:
  - a. Sri Omkara Bhagavath Gita Vedantha Annadhana Ashramam - Rs.250/-
  - b. Sri Lakshmi Narayana Swamy Temple - Rs.350/-
4. I submit that since the date of my initial appointment, I am working in the above temples without any remarks from any corner.
5. I submit that at present I am paid as follows from the 4<sup>th</sup> respondent temple:
  - a. Rs.2,500/- from Temple Fund
  - b. Rs.1,000/- towards Paditharam
  - c. Rs.8,000/- from Archaka Welfare Fund
  - d. Total - Rs.10,500/-

6. I submit that I am paid Rs.2,500/- + Rs.1,000/- by the 4<sup>th</sup> respondent Temple, but coming to the payment of Rs.8,000/- from the Archaka Welfare Fund. The salary from the said fund is not paid to me from August 2021, as such I have submitted representation to the 3<sup>rd</sup> respondent. In turn, the 3<sup>rd</sup> respondent has sought report from the Executive Officer and thereafter submitted his report in Rc. No.B2/E.No.1061452/2021 dated 14-12-2021 to the 2<sup>nd</sup> respondent informing, that I have not been paid salaries from August 2021 and requested to release the arrears from Archaka Welfare Fund.
7. I submit that thereafter I have submitted representation to the 2<sup>nd</sup> respondent on 1-5-2022, requesting that I am not getting salaries from August 2021. In turn, the 2<sup>nd</sup> respondent issued a Memo in Rc. No.COE-24026/59/2022 dated 6-5-2022 directing the 3<sup>rd</sup> respondent to submit report why the remuneration is not paid to me even after the remuneration was released from the office of the Commissioner, Endowments Department.
8. I submit that thereafter, I have approached the office of the 3<sup>rd</sup> respondent and I was made to run from pillar to post by the office of the 3<sup>rd</sup> respondent to get my arrears salaries, but as on today not even single paise is paid to me. Further I am due Rs.8,000/- per month from August

2021 to till date i.e., 10 months totaling to Rs.80,000/-.

Hence seeking payment of the same, the present writ petition is filed.

9. I submit that my family is depending upon my salaries. If my salaries are not paid, I will be put to irreparable loss and injury and the same cannot be compensated by any means.

10. The petitioner has no other alternative and efficacious remedy except to approach this Hon'ble Court under Article 226 of constitution of India.

11. The petitioner has not filed any suit, application or petitions before any court of law and we have not sought for any similar relief.

In the above mentioned circumstances, it is therefore prayed that this Hon'ble Court may be pleased to issue an appropriate Writ order or direction more particularly, one in the nature of Writ of Mandamus, declaring the action of the respondents 2 and 3 in not paying the salaries from August 2021 to till date to the petitioner from Archaka Welfare Fund as bad, Illegal, arbitrary, violative of principles of natural justice and violative of Articles 14, 21, 25 & 300A of Constitution of India and consequently direct the respondents 2 and 3 to forthwith pay the arrears of salaries and continue to pay the





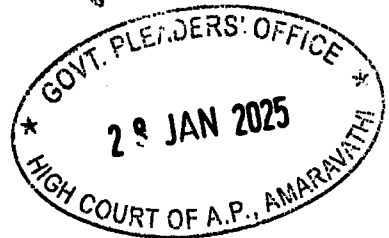
