1. I am the 1st petitioner herein and as such I am well acquainted with the facts of the case. I am also authorized to file this present contempt case on behalf of the 2nd petitioner also for the common cause of action.
2. It is submitted that the present writ petition being filed by the petitioner praying that this Hon'ble Court may be pleased to issue an appropriate writ order or direction more particularly one in the nature of Writ of Mandamus to declaring the inaction of the Respondents to dispose of the petitioners Online applications vide applications No. TTA012400117990 & TTA012400117989 dt 02.02.2024 to delete the petitioner schedule land from the Prohibited list of properties and to mutate the petitioner names in the revenue records and to issuance of Pattadar pass books and Title deeds in Sy.no.259/2A for an extent of Ac 0.18 cents and for an extent of Ac 0.09 cents at Jalantara Sompeta, Sompeta town and mandal, Srikakulam District is highly illegal arbitrary violation of Articles 14, 21 and 300A of the Constitution of India and also violation of the ROR Act and also violation of the principles of natural justice consequently direct the Respondents to dispose of the petitioners Online applications vide applications No. TTA012400117990 & TTA012400117989 dt 02.02.2024 to delete the petitioner schedule land from the Prohibited list of properties and to mutate the petitioner names in the revenue records and to issuance of Pattadar pass books and Title deeds in Sy.no.259/2A for an extent of Ac 0.18 cents and for an extent

of Ac 0.09 cents at Jalantara Sompeta, Sompeta town and mandal, Srikakulam District.

3. It is submitted that petitioners are the absolute owner and possessor of the above said ancestral properties and continuous possession and enjoyment of the same without any interruption of the any third parties as well as Respondents authorities to claim the above said petitioner's properties.

4. It is submitted that petitioners were purchased the above said land in Sy.no.259/2A for an extent of Ac 0.18 cents and for an extent of Ac 0.09 cents at Jalantara Sompeta, Sompeta town and mandal, Srikakulam District under Registered sale deed dt 13.04.1977 and 27.11.1979 at Joint Sub-registrar office at Sompeta, Srikakulam district from the Executive Officer Group Temples Sompeta, since then the petitioners are continuous possession and enjoyment of the same without interruption of the respondents authorities as well as any third parties.

It is submitted that petitioners were intended to purchase the above said properties approached the 7th respondent office then the 7th respondent office orally informed to the petitioners that the above said petitioner properties shown as a prohibited list of properties U/s 22A of registration Act. Then petitioner were made an application before the respondent authorities vide Online applications vide applications No.TTA012400117990 & TTA012400117989 dt 02.02.2024 to delete the petitioner schedule properties from the prohibited list of properties. Since then the respondents neither disposed of the petitioner application nor deleted the petitioner lands from the prohibited list of properties. Even then the 3rd respondent herein issued a proceedings dated 03.05.2015 in favour of the petitioners. Hence the present writ petition.

It is submitted that then the petitioner was filed wp.no.3131/2024 against the respondents and said wp.no.3131/2024 was came up for admission on 25.4.2024 and this Hon'ble court was pleased to disposed of the above writ petition.No.3131/2024 by orders dated 25.4.2024 with a direction to the 1st Respondent/contemnor to dispose of the petitionersOnline applications vide applications No.TTA012400117990 & TTA012400117989 dt 02.02.2024to delete the petitioner schedule properties from the prohibited list of propertiesdeeds in Sy.no.259/2A for an extent of Ac 0.18 cents and for an extent of Ac 0.09 cents atJalantaraSompeta, Sompeta town and mandal, SrikakulamDistrict. With in a period of (2) months from the date of the receipt of the copy of the order, strictly in accordance with law and communicate the same to the petitioner.

It is submitted that the things stood thus above the 1st respondent/contemnor herein was issued an intimation proceeding dt 07.08.2024 to the 2nd respondent /contemnor stating that to direct the 4th respondent/contemnor and joint collector to make sub-division in Sy.no.259/2A for an extent of Ac 0.18 cents and for an extent of Ac 0.09 cents atJalantaraSompeta, Sompeta town and mandal,

ORDER

Heard learned counsel for the petitioners, learned Assistant Government Pleader for Revenue appearing on behalf of respondent Nos.1, 4, 6 and 7 and learned Assistant Government Pleader for Endowments appearing on behalf of respondent Nos.2, 3 and 5.

2. The writ petition is filed to declare the inaction of the respondents in disposing the petitioners' online applications Nos.TTA012400117990 and TTA012400117989 dated 02.02.2024 requesting the authority to delete an extent of Ac.0-18 cents and Ac.0-09 cents respectively in Sy.No.259/2A of Jalantara Sompeta, Sompeta Town and Mandal, Srikakulam District, as illegal and arbitrary.

3. Learned counsel for the petitioners would submit that the petitioners are the absolute owners of the property of an extent of Ac.0-18 cents and Ac.0-09 cents respectively. However, the said properties are included in the prohibited properties list under Section 22-A(1)(c) of Registration Act, 1908. Hence, the petitioners made online applications to delete the subject properties from the prohibited properties list. However, the authorities are not considering the online applications. Hence, the writ petition.

4. Counter-affidavit was filed on behalf of respondent No.7. It was contended, inter alia, that as per the latest list notified by Revenue authorities, Sy.No.259-2A in an extent of Ac.5-84 cents of Jalandrasompeta revenue village is classified as "Endowment Land"

owned by Sri Kodanda Rama Swamy Temple prohibited under Section 22-A(1)(c) of Registration Act, 1908. Unless the petitioner's property is not deleted from the prohibited list under Section 22-A(1)(c) of Registration Act by the competent authority, the authority has no power to receive and register the document.

5. Learned Assistant Government Pleader for Endowments on instructions would submit that the 3rd respondent/Commissioner will pass appropriate orders in accordance with law.

6. In view of the submission of learned Assistant Government Pleader for Endowments and in view of the facts and circumstances of the case, without going into other facts of the case, the Writ Petition is disposed of directing the 3rd respondent – Commissioner of Endowment Department to consider and dispose of the online applications submitted by the petitioner bearing Nos.TTA012400117990 and TTA012400117989 dated 02.02.2024 requesting to delete their property of an extent of Ac.0-18 cents and Ac.0-09 cents respectively in Sy.No.259/2A of Jalantara Sompeta, Sompeta Town and Mandal, Srikakulam District, within a period of two (2) months from the date of receipt of a copy of the order, strictly

in accordance with law, and communicate the same to the petitioners. No order as to costs.

As a sequel, pending miscellaneous petitions, if any, shall stand dismissed.

It is submitted that petitioners were purchased the above said land in Sy.no.259/2A for an extent of Ac 0.18 cents and for an extent of Ac 0.09 cents at Jalantara Sompeta, Sompeta town and mandal, Srikakulam District under Registered sale deed dt 13.04.1977 and 27.11.1979 at Joint Sub-registrar office at Sompeta, Srikakulam district from the Executive Officer Group Temples Sompeta, since then the petitioners are continuous possession and enjoyment of the same without interruption of the respondents authorities as well as any third parties.

5. It is submitted that petitioners were intended to purchase the above said properties approached the 7th respondent office then the 7th respondent office orally informed to the petitioners that the above said petitioner properties shown as a prohibited list of properties U/s 22A of registration Act. Then petitioner were made an application before the respondent authorities vide Online applications vide applications No.TTA012400117990 & TTA012400117989 dt 02.02.2024 to delete the petitioner schedule properties from the prohibited list of properties. Since then the respondents neither disposed of the petitioner application nor deleted the petitioner lands from the prohibited list of properties. Even then the 3rd respondent herein issued a proceedings dated 03.05.2015 in favour of the petitioners. Hence the present writ petition.

6. It is submitted that the petitioners have no other alternative efficacious remedy, except to approach this Hon'ble Court under Article 226 of the Constitution of India and not filed any writ or suit or other proceedings for seeking same relief in the present Writ Petition.

For the reasons stated above it is therefore prayed that this Hon'ble Court may be pleased to issue an appropriate writ order or orders or direction more particularly one in the nature of Writ of Mandamus to declaring the inaction of the Respondents to dispose of the petitioners Online applications vide applications No.TTA012400117990 & TTA012400117989 dt 02.02.2024 to

I invite your attention to the subject matter.

I wish to inform that Sri Kedanda Rama Swamy Temple, Sompeta is endowed with an extent of Ac.6.18cents in Sy.No.259/2A of Jalantara Sompeta, Sompeta Town. Out of the said total extent, an extent of land measuring Ac.0.29 Cents was duly sold away in public auction in the year 1976 to (3) persons. The balance property was prohibited under Sec.22-A(1)(c) of Registration Act.

As the matter stood thus, Sri K. Appala Raju and others filed a Writ Petition No.3131 of 2024 with a prayer to delete the petitioners schedule land measuring Ac.0.18 cents and Ac.0.09 cents in Sy.No.259/2A of Jalantara Sompeta, Sompeta Town, from the prohibited list of properties and to mutate the petitioner names in Revenue Records and to issue of Pattadar Pass Books and Title deeds. The Honble High Court vide Order dated 25.04.2024 disposed off the Writ Petition with a direction to the Commissioner of Endowments to consider the online applications in accordance with law within (2) months from the date of issue of the orders.

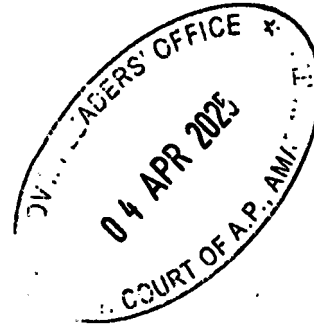

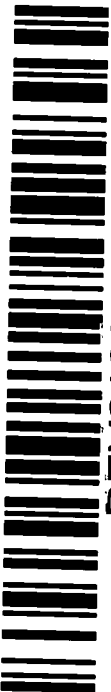
