AFFIDAVIT OF KOGANTI RAVI KUMAR

I, Koganti Ravi Kumar, s/o Tiruvengala Acharyulu, aged about 55 years, R/o Vijayalakshmi towers, Opp. Autonagar Bus stop, Vijayawada, do hereby solemnly affirm and state on oath as follows:

1) I am the petitioner and I am well acquainted with facts of the case.

2) I submit that, I am filing the present writ petition challenging the Memo dated 17.04.2025 in Rc. No. A1/11026(43)/74/2022 issued by the 2nd respondent and consequential letter No. 9/2025 dated 21.04.2025

issued by the 3rd respondent repatriating me to the 4th respondent without resolving the capacity of 4th respondent's capacity to pay my salary, as illegal, arbitrary, violative of provisions of AP Charitable and Hindu Religious Institutions and Endowments Act, 1987 and rules made thereunder and contrary to Articles 14, 19(1)(g) & 21 of Constitution of India.


3) I submit that, I am working as Junior assistant in the 3rd respondent institution. Originally, I was recruited in the 4th respondent institution. As the financial condition of the 4th respondent has weakened, in view to protect my service and my interests, in the year, the 4th respondent by it's letter dated 10.10.2022 submitted a report that, earlier I was deputed to 3rd respondent in the year 2001 and repatriated; then due to the poor financial condition of the 4th respondent temple, 10% of my salary is permitted to draw in that institution and 90% of salary from another institution; subsequently that arrangement is also cancelled; hence, as the 4th respondent is not in a position to bare my salary, requested to transfer/depute me to some other financially viable institution. Acting upon the same, the then Deputy Commissioner, submitted a letter dated 21.11.2022 in Computer No. B2/446659/2022 requesting the 2nd respondent to pass appropriate order on my request for deputation. On 08.12.2022, the then 2nd respondent issued proceedings in Rc. No. A2/11026(43)/74/2022 deputing me to the 3rd respondent for a period of 2 years. As such, I am serving as junior assistant in the 3rd respondent institution.

4) I submit that, the 4th respondent-my parent institution is a 6(c)-institution having it's income very less. The temple is already burdened with it's archaka's salary and other expenses as clearly shown in a separate annexure herewith. The income gained by the 4th respondent

institution is already shortfall of the existing expenses. Now, I am drawing Rs. 42,117/- per month. As per the same, my annual salary is Rs. 5,06,000/-. But, the current income of the 4th respondent is only Rs. 3,35,000/-. Hence, the 4th respondent could not bare archaka's salary, my salary and other expenses. As such, on 23.12.2024, I requested the 2nd respondent to take action for continuation of my deputation or pass any appropriate orders for addressing my grievance. The 3rd respondent also submitted a letter dated 18.12.2024 to 2nd respondent to pass appropriate orders. Then the 2nd respondent issued Memo dated 30.01.2025 seeking information as to the annual income and establishment charges of the 3rd respondent institution.

5) I submit that, the 3rd respondent by letter No. 9/2025 dated 05.02.2025 submitted a report suppressing the actual income of the institution, with the distorted facts and shown the establishment charges as 69%. Hence, the 2nd respondent issued the impugned proceedings dated 17.04.2025 repatriating me to 4th respondent and the 3rd respondent consequentially issued letter dated 21.04.2025 relieving me from the 3rd respondent institution. The 3rd respondent in it's letter dated did not mention the income that is accrued on the Fixed Deposits of the 3rd respondent institution. If the actual income is shown, the establishment charges would be very much less than 69% probably nearly 30% only. The 3rd respondent is 6(b) institution with income above 20 lakhs and the 4th respondent is 6(c) institution with income around 3.5 lakhs. Establishment charges less or something, the 3rd respondent can bare my salary as it done on earlier occasion and now. But, the 4th respondent expressly is not in a position to bare already existing salaries and further cannot bare my salaries. If the impugned proceedings are allowed to continue, it would result me working in an institution without salary, affecting my basic livelihood and fundamental rights. I have aged

parents and studying daughters. I have to take care of all the necessities which cannot be done without salary.

6) I submit that, the religious institutions having income less than 5 lakhs fell for discussion in Hon'ble Apex Court that, incomes with less income cannot be burdened with secular staff and statutory deductions and the 1st respondent undertook before Apex Court that, they would exempt the institutions of income less than 5 lakhs from certain provisions of the Act which among them is appointing secular staff. The government has already taken a policy decision that, the temples of annual income below 5 lakhs to be administered by the FFM/archakas/interested persons and pursuant to the same, administration of many temples is already handed over to respectively. On one hand that being the case, the impugned proceedings again sending me back to a 6(c) temple which already burdened with archaka's salary is non-application mind. I have already submitted a representation dated 23.12.2024 requesting to extend my deputation or pass appropriate orders. I am ready to work in any other institution in the district by transfer/deputation where such institution is financially viable to pay my salary. But, the respondent officials erroneously repatriated me to the 4th respondent. The said action is nothing but indirectly denying me my salary which cannot be permitted by law. Hence, the impugned proceedings are illegal, arbitrary and unsustainable in the eye of law.

7) Under these circumstances stated above, I have no other efficacious alternative remedy, except to approach this Hon'ble Court under Article 226 of the Constitution of India.



In the reference 2nd cited Sri k. Ravi Kumar, Jr Asst of the subject temple put as representation with a request to depute to any other institution as he is not getting salaries from his Parent Temple i.e sri Malleswar Swamy Temple, Kondiparru due lack of funds.

In view of the above representation, I submit the following few lines for your kind perusal and for taking necessary action.

Sri Malleswra Swamy temple, Kondiparru Village is published U/s 6(C)(ii) of the Act 30/87 and it is under the administrative control of the Assistant Commissioner, Endowment Department, Krishna District. It is managed by Executive Officer, Grade II. The temple endowed land an extent of Ac 08.80 Cts only. The following are the details of income derived for the last 3 years.

1.	2019-20	1,38,592/-
2	2020-21	1,61,828/-
3	2021-22	1,63,500/-

Whereas the expenditure towards salary of Archaka; Sweeper, Padiditharam etc, of Rs. 1,00,000/- and therefore it will become difficult to perform Kalyanam and to pay Electrical charges and also Revenue Panchayathi Taxes etc, therefore the institution won't be able to bare the salary of Sri Koganti Ravi Kumar, Junior Assistant of the Subject temple.

I submit that, He is working as a Junior Assistant in the subject temple from 01-04-1992 on consolidated basis. There up on the Commissioner, Endowment Department, Hyderabad has regularized his services with 1986 pay scales on 31-08-2000 vide his proceedings in D.Dis No. B1/16672/2000 dated 31-08-2000.

There after, the Trustee of the subject temple sanctioned 1993 RPS with prior permission of the Commissioner, Endowment Department, Hyderabad vide in his circular proceedings in Rc.No J2/12961/91 dated 19-01-1999 w.e.f 01-09-2001. After that his services were deputed to Sri Gunturu Sitaramaiah Anna Satram Trust, Vijayawada by the Commissioner, Endowment Department, Hyderabad vide in his proceedings in D. Dis No I 4/50246/2001 dated 05-11-2001. Later, he put a representation to the Deputy Commissioner, Endowment Department, Kakinada with a request to sanction 1999 Revised Pay Scales, consequently the Deputy Commissioner, Endowment Department, Kakinada has sanctioned 1999 PRC vide in his proceedings in D.Dis No B2/3915/2004 dated 14-02-2004 with effect from 01-02-2004.

There up on his services were authorized as Manager to Sri Rama Lingeswara Swamy temple, Balive Village, Musunuru Mandal, Krishna District by the Commissioner, Endowment Department, Hyderabad vide in his proceedings Rc.No E3/11960/2004 dated 25-03-2004. After a while, he put a representation to the Assistant Commissioner, Endowment Department, Vijayawada with a request to sanction 2005 RPS and that was also sanctioned vide in his proceedings in L.Dis No B1/6153/2007 dated 08-08-2007.

There after his services were repatriated to his parent Institution which is Sri Malleswara Swamy temple, Kondiparru Village, Pamarru Mandal, Krishna District by the Deputy Commissioner, Endowment Department, Kakinada by the orders in Rc. No B4/18890/2006 dated 30-06-2009, subjected to these orders he rejoined in his parent institution.

After few years he put a representation to the Commissioner, Endowment Department, Gollapudi for 2010 Pay Scales then the Commissioner Sanctioned 2010 Revised Pay Scales vide in her proceedings in Rc.No A1/11026/34/2/2020 dated 08-01-2020. Currently he received the following allowances as my monthly salary:
