AFFIDAVIT

I, Irupani Subbarao, S/o. Chinna Ankaiah, Aged 54 years, Occ: Cultivation, R/o. Chundi Village, Voletivaripalem Mandal, SPSR Nellore District, do hereby solemnly affirm and state as follows:

1. I am the petitioner herein and as such I am well acquainted with facts of the case.
2. I humbly submit that the present writ petition is filed, aggrieved by the action of 5th respondent in deleting our names in revenue records including online web land revenue records for our agricultural land admeasuring Ac.3.00 Cents excluding Ac 0.20 Cents covered by temple in Survey No.78/1, situated in Chundi Revenue Village, Voletivaripalem Mandal, SPSR Nellore District and recording the name of the 6th respondent in revenue records including the Online Web Land Revenue Records as pattadar and possessor for our said land, without issuing notice and inviting objections from us in violation of principles of natural justice and contrary to the provisions of the Andhra Pradesh (Telangana) Rights in Land and Pattadar Passbooks Act, 1971 and rules framed there under.
3. I further humbly submit that originally my father by name Chinna Ankaiah is the absolute owner, possessor and enjoyer of the land admeasuring an extent of Ac.3.00 Cents excluding Ac 0.20 Cents covered by temple in Survey No.78/1, situated in Chundi Revenue Village, Voletivaripalem Mandal, SPSR Nellore District. He acquired the same under sale agreement dated. 04.06.1977. Since then, he had been cultivating the said land without any interruption at any point of time by paying taxes to the Government. Pattadhar Passbook and Title Deed was also issued in his name and his name was also mutated in the Web Land Revenue records in respect

of the above said lands. Subsequently, my father died intestate and the aforesaid land devolved upon me and the same is within the knowledge of one and all including the respondents.

4. I further humbly submit that the above said lands are originally Ex-Zamindari lands, the government has taken away all the lands from zamindar. Therafter RDO issued proceedings with Ref.No. B2/10768/52 dated 02.11.1953 stating that some extent of lands given back to R.K.B.Krishnappa Nayunimva Ex-zamindar of Chundi Estate, thereafter Additional Assistant Settlement Officer issued proceedings vide M.R.S.R. No. 5/56 dated 22.11.1956 stating that said lands are private lands.

5. I further humbly submit that while it so, all of a sudden the 5th respondent removed our aforesaid khata numbers allotted to us and also the survey numbers of the aforesaid lands allotted to us from the online records, without issuing any notice to us or passing any orders to that effect. On account of this unilateral action on the part of the 5th respondent, our title, ownership and possession over the aforesaid lands cease to be evidenced and supported by the revenue records and webland records which is mandatory for all practical purposes including availing financial assistance from the banks and other institutions and also to avail the support and assistance being extend by Government under various schemes. Having come to know about this removal of entries pertaining to our lands from the revenue records, we approached the 5th respondent and submitted a detailed representation requesting to restore the lands and corresponding entries in respect of our ownership and possession. The respondents received my said representation but did not respond on the same till date.

6. I further humbly submit that the respondents particularly the 5^h respondent under legal obligation to respond on my representation/objections

on adding my name in online revenue records in respect of the aforesaid land. The respondents particularly the 5th respondent neither did issue any notice to me nor hold any inquiry before deleting my name in the online records pertaining to my land through it is mandatory on the Part of respondents as held by Full Bench of this Hon'ble Court in **Chinnam Pandurangam Vs. Mandal Revenue Officer, Serilingampally Mandal, Ranga Reddy District and Others reported in W.P.No.7868 of 2004**. The predecessor-in-office of the 5th respondent issued the Pattadar Pass Book cum Title Deed, after duly satisfying with my eligibility and entitlement there for, cannot unilaterally withdraw the same without giving any notice to me and receiving my objections and conducting enquiry giving fair opportunity of hearing to me. The action of 5th respondent in deleting my name in the online record relating to my lands amounts to fouling of my pass book, which is highly illegal, irregular and without any authority or sanction of law.

7. I further humbly submit that the respondents do not have any authority of law or sanction of law to delete my name in revenue records including online web land revenue records for my aforesaid agricultural land. Respondents being state and its functionaries are under legal obligation to trace any source of law before deleting my name from the revenue records, as contemplated under the administrative law doctrine of legitimate expectation. The action of respondents is illegal, irregular, irrational being violative of Articles 14, 21 and 300A of Constitution of India. Even otherwise, if the respondents have any jurisdictional issue to be decided connected to my record of rights, they should invoke the provisions of Andhra Pradesh Rights in Land and Pattadar Pass books Act, 1971 and rules framed there under, but in case on hand no such proceedings were initiated. I have prima facie title and possession as well as record of rights connected to my said land. If the

impugned entries are allowed to stand, I would suffer deprivation of property and resultantly my livelihood as guaranteed under Articles 14, 21 and 300-A of Constitution of India would be adversely effected. Thus I am constrained to file the present writ petition.

8. I have no other alternative remedy except to approach this Hon'ble court invoking its extra ordinary jurisdiction under Article 226 of the Constitution of India. I have not filed any suit or Writ or any proceedings before any court or Tribunal nor any Writ or suit is pending before any court or Tribunal seeking the relief sought for in this Writ Petition.

These lands are registered as government lands by our village government in the village census, but according to the orders of Kandukur Ramana Adhikari, ref:- No B2/10768/52 dated 02/11/1953, the place near our Pathikota Fort (the area of Chundi Raja's fort) survey number 78/1 area 3-20 cents has been acquired by us, but even so far it has been registered as government land in the two village censuses. So far, our name has not been transferred. We sold this land to our village residents 1. Irupani Chinna Antaiah S/o Ramaiah 2. Irupani Sarasamma w/o Narasimha, 3. Irupani Satyanarayana s/o Narasimha 4. Irupani Suryanarayana S/o Narasimha on 04-06-1977. When we went to the Sub-Registrar's office for registration, they told us that this land was registered as government property. The Mandal authorities, with the kindness of our Hindus, requested the Revenue Divisional Officer of Kandukur to transfer the land in our possession to our name as per ref:- No B2/10768/52 date 02/11/1953.

O R D E R :

This an application filed by Sri R.K.B. Krishnappa Nayanamvaru, Ex-Zaminder of Chundi village under Section 15(1) of Act XXVI of 1948 for the grant of a Ryetwari patta in respect of the lands mentioned in the schedule to these proceedings situated in Chundi Village of Kandukur taluk, Nellore District. This village is a Zamin village in Chundi Estate taken over by Government on 7.9.1950. The grant of otherwise of a patta in this case will have to be regulated under the provisions of section 12 of the Act.

2. Notices were served and published as per rules. No objections were filed. The applicant appeared and gave evidence. His father, Sri Ankappa Nayunimvaru was the ruling prince of Chundi Estate and was paying Peshkush of Rs. 18,000/- to Government annually. He died in 1938. During the minority of the applicant his mother handed over the personal properties of the minors to the Court of wards through the Revenue Board at Madras. The Court of wards managed the properties from 1938 to 1953. The Government took on the Estate also through the Court on wards. After the applicant on 2.11.1953. In view of the fact that peshkush was being paid by the father and fore-fathers of the applicant to Government and the applicant being a direct dispendent of the Zamindar family, he claims to be treated as and holder as defined in the Estate Land Act. No objections have been filed, in this respect. He is deemed a landholder.

3. All the lands taken over by the Court of wards were being managed by the Court of Wards from 1938 to 1953. They were auctioning the right of cultivation in the lands and the usufruct of tree in topes. The applicant and the other members of the family were being paid an amount of Rs.1600/- per month for maintenance by the Court of Wards. The applicant also has 4 yokes of bulls and took after cultivation with the help of his farm servants at Chundi. The fact is that the lands came into possession of the Zamindars of Chundi. The fact is that the lands have been enjoying them from the time immemorial. They are treated as private lands of the Zamindar and find place in the pattas held by the Zamindars.

4. The village has been only recently surveyed and the survey records have not been finalised and hence only O.S. Nos. are adopted.

5. The lands now applied for are all Mango topes, planted and earned by the father and fore-father of the applicant. They were utilising the produce for themselves and selling only the surplus to others. The Court of wards were sanctioning the usufruct of those trees which are about 120 in number year treating the lands of home-farm-lands of the ward. But while delivering back the properties of the ward the Court of wards did not deliver back these mango topes. The Government is continuing to auction the usufruct of the mango trees from the year, 1953. The applicant represented to Andhra Pradesh State Government due to him. This notice was issued on 9.8.56 and the right of it is not yet known. All these items are treated as home-farm-lands of the Zamindar by local custom and the Court of wards as well. The applicant is entitled to patta under Section 12(a) of the Act. His claims are allowed under Section 15(1) of the act.
