AFFIDAVIT

I, Sarangapani Mohan Kumar, S/o. Late Ramakrishna, Age 37 years, Occ : Superintendent in Sri Satyamma ammavari Temple, Ambarupeta village, Nandigama Mandal, NTR District having temporarily come down to Vijayawada, do hereby solemnly affirm and sincerely state on oath as follows:

1. I submit that, I am the petitioner and deponent herein, as such I am well acquainted with the facts of the case.

2. It is submitted that the present writ petition is filed challenging the action of the 2nd respondent in issuing proceedings in L. Dis No. A1/11026(36)/5/2024 dated 17.01.2025 abolishing the post of Superintendent in 3rd respondent temple as bad, illegal, arbitrary and violative of articles 14, 16 & 21 of Constitution of India.
3. I humbly submit that, I was initially appointed on 10.11.2008 on compassionate grounds in the cadre of Record Assistant. I was promoted as Junior Assistant on 18.02.2011, further promoted as Senior Assistant on 08.01.2020, finally I was promoted as Superintendent on 13.03.2024 in the 3rd respondent temple. Hence 3rd respondent is my parent institution, there is no dispute with regard to the same.
4. I submit that, as per the cadre strength of the 3rd respondent temple approved by the Regional Joint Commissioner, Kakinada, there are 1 record Assistant, 1 Junior Assistant, 1 Senior Assistant and 1 Superintendent posts are sanctioned.
5. I submit that, one GN.Ratnakara Rao who is born employee of Brahmaiah Lingeswara Swamy Temple, Chikkavaram Village, Gannavaram Mandal, Krishna District was working on transfer in the 3rd respondent in the cadre of Senior Assistant, when I was appointed in the year 2008.
6. I submit that, the said GN.Ratnakara Rao has taken promotion as Superintendent in the year 2013 in 3rd respondent temple which is other than his parent institution. In fact in the said vacant Senior Assistant post because of his promotion I was to be promoted from Junior Assistant to Senior Assistant, but the same was not done, even when I have submitted representation to the EO, finally I was promoted as Senior Assistant with a delay of around 8 years in the

year 2020, even when I was eligible, qualified and parent temple employee in the year 2013 itself.

7. I submit that, thereafter the said GN.Ratnakara Rao who was enjoying the post of superintendent in my parent institution was transferred in the year 2021 to Veadri Temple and the Superintendent post fell vacant, but I was not granted promotion in the said vacant post as GN.Ratnakara Rao did not have lien over the said post. Further in the year 2022 again GN.Ratnakara Rao was transferred to 3rd respondent temple from Veadri Temple.
8. I submit that, subsequently in the year 2023 GN.Ratnakara Rao was again transferred to Veadri Temple from 3rd respondent temple and one B.Ravindra Babu, Superintendent Sri Ramalingeswara Swamyvari Devasthanam, Nandigama was transferred to the 3rd respondent temple and thereafter he was appointed by transfer of service as EO, Gr-I in the month of February, 2024 and in the said vacant post, I was promoted as Superintendent in the month of March, 2024.
9. I submit that, it is not out of place to submit here that while GN.Ratnakara Rao working as Superintendent on transfer in the 3rd respondent temple, the then Regional Joint Commissioner, Kakinada has issued proceedings dated 23.03.2015 abolishing the post of Superintendent and repatriating said GN.Ratnakara Rao, challenging the same he has filed WP No. 17205/2015 and interim orders were granted on 17.06.2015, thereafter 2nd respondent has issued orders keeping RJC orders in abeyance on 29.10.2016.
10. I submit that, WP filed by GN.Ratnakara Rao got closed as infructuous as he was transferred in the cadre of Superintendent to Veadri Temple on 07.07.2023.

- 11.I submit that, in the meanwhile the 2nd respondent has issued proceedings dated 08.01.2020 abolishing the post of Superintendent in the 3rd respondent temple. Immediately thereafter 2nd respondent issued another proceedings on 08.02.2020, wherein it was mentioned that Superintendent is existing in the 3rd respondent temple and the lien of GN.Ratnakara Rao in the cadre of Superintendent is in the 3rd respondent temple and not to effect any promotion in the 3rd respondent temple. Even after issuing the said proceedings one B.Ravindra Babu was transferred in the said position. As such it is crystal clear that there is necessity of superintendent.
12. I submit that, thereafter the 2nd respondent has issued proceedings dated 14.03.2024 restored the abolished Superintendent post and permitted 3rd respondent to grant me promotion as Superintendent, as such I was promoted to the post of Superintendent by the 3rd respondent.
- 13.I submit that, behind my back on anonymous complaint was made by one K.Venkateswara Rao dated 28.10.2024 to the CM office, acting on the same without even issuing notice and without even affording opportunity to me to substantiating my claim impugned proceedings dated 17.01.2025 are issued abolishing Superintendent post in the 3rd respondent temple in which I am presently working from the past 10 months, this impugned orders are in punitive in nature, as such Principles of Natural Justice have to be followed and I have to be given opportunity of cross examining the complainant, submit my defense. There cannot be a public interest complaint in the service matters, as such the action

of the respondent in issuing impugned proceedings is illegal and arbitrary, on this ground alone the writ petition has to be allowed.


14.I submit that, the impugned orders referred to GO 183 dated 25.05.2017, which mentions that there cannot be a Superintendent post to the temple having less than Rs.1 crore income for 3 consecutive years. There are service rules governing the employees of the Endowment Institution as per GOMs No. 888 dated 08.12.2000, without amending the rules instructions cannot be issued by virtue of GOMs No. 183. The instructions cannot supplant the rules, as such this ground is illegal and arbitrary. Further there are only instructions but not rules or directions.

15.I submit that, reference is made to GOMs No. 231 dated 01.06.2023 mentioning that for sanction of Superintendent post the Commissioner shall consent Govt. before such sanction. In the instant case the Superintendent post was sanction long back, abolished and revoked, as such it does not amount to sanction of new post. Further the proceedings of the Commissioner dated 14.03.2024 clearly mentions the necessity of the superintendent and posting the superintendents at regular intervals establishes the necessity of superintendent in the subject temple, as such the impugned orders are liable to be set aside.

16.I submit that, unless the impugned orders are set aside and I am allowed to perform the duties of superintendent, I will be put to irreparable loss and injury which cannot be compensated by any means.

17. I submit that, in the circumstances stated above, the petitioner has no efficacious alternative remedy except to approach this Hon'ble Court under Article 226 of constitution of India.





18. I submit that, the petitioner has not filed any writ petition, suit or other proceedings for the relief or relieves sought herein.

In the above mentioned circumstances, it is therefore prayed that the Hon'ble Court may be pleased to issue a writ order or direction more particularly, one in the nature of writ of Mandamus, declaring the action of the 2nd respondent in issuing proceedings in L. Dis No. A1/11026(36)/5/2024 dated 17.01.2025 abolishing the post of Superintendent in 3rd respondent temple as bad, illegal, arbitrary and violative of articles 14, 16 & 21 of Constitution of India and consequently set aside the same and direct the respondents to grant all monitory and service benefits to the petitioner in the cadre of Superintendent and pass such order or orders as this Hon'ble Court deems fit and proper in the facts and circumstances of the case.

Pending disposal of the writ petition, it is therefore prayed that this Hon'ble Court may be pleased to suspend the operation of impugned proceedings issued by the 2nd respondent in L. Dis No. A1/11026(36)/5/2024 dated 17.01.2025 and pass such order or orders as this Hon'ble Court deems fit and proper in the facts and circumstances of the case.

In the reference 1st cited, the Regional Joint Commissioner, Endowments Department, Rajamahendravaram has sanctioned one post of Superintendent along with other posts in the cadre strength of Sri Satyamma Ammavari Temple, Ambarupeta (V), Nandigama(M), Erstwhile Krishna District and present NTR District.

Later, in the reference 2nd cited, the post of Superintendent in the existing cadre strength of Sri Satyamma Ammavari Temple, Ambarupeta(V) was abolished by the Regional Joint Commissioner, Endowments Department, Rajamahendravaram.

Subsequently, the orders issued by the then Regional Joint Commissioner, Endowments Department, Rajamahendravaram in the reference 2nd cited, were kept in abeyance by the Commissioner of Endowments vide reference 3rd cited.

Thereafter, vide reference 4th cited, the Commissioner of Endowments has abolished the post of Superintendent in the existing cadre strength of Sri Satyamma Ammavari Temple, Ambarupeta(V) for administrative convenience.

In the reference 6th cited, the post of Superintendent as abolished in the reference 4th cited has been restored in the existing cadre strength of Sri Satyamma Ammavari Temple, Ambarupeta(V) and the Executive Officer of Sri Satyamma Ammavari Devasthanam, Ambarupeta(V) has been permitted to promote Sri S.Mohan Kumar, Senior Assistant to the cadre of Superintendent in the existing vacancy, if he is found eligible and qualified in terms of G.O.Ms.No.888, Dt.08.12.2000 and the post of Senior Assistant in the existing cadre strength of Sri Satyamma Ammavari Devasthanam, Ambarupeta(V) has been abolished.

In the reference 7th cited, Sri K.Venkateswara Rao S/o Chinna Abbai, R/o Hanumanthapuram has filed a complaint petition stating that Sri S. Mohana Rao got promotion as Superintendent in the establishment of Sri Satyamma Ammavari Temple, Ambarupeta(V) in an illegal way by violating the rules and regulations and requested to curb this type of illegal promotions and rule violations in the temples.

The above complaint petition has been examined with reference to G.O.Ms.No.183, Rev (Endts-I) Dept, Dt.25/5/2017 and G.O.Ms.No.231, Rev(Endts-I) Dept, Dt.1-6-2023.

The norms fixed in G.O.Ms.No.183,Rev.(Endts-I) Dept, Dt. 25/5/2017 for sanction of posts in the cadre of Superintendent in the temples have to be followed while sanctioning the posts of Superintendent in the temples. As per the above G.O, the post in the cadre of Superintendent in the temple can be sanctioned only if the assessable income of the temple is more than Rs.one Crore for three consecutive years.

Where as the assessable income of Sri Satyamma Ammavari Temple, Ambarupeta(V) is below one crore rupees for the last three consecutive years as follows, as per the report of the Executive Officer in the reference 5th cited.

In the instant case, Sri Satyamma Ammavari Temple, Ambarupeta(V) is not entitled for sanction of Superintendent post as per the norms fixed in G.O.Ms.No.183,Rev.(Endts-I) Dept, Dt.25/5/2017 since the assessable income is below One crore rupees per annum.

Further G.O.Ms.No.231, Rev(Endts-I) Dept, Dt.1-6-2023 says that " In case of sanction of only new category of posts or new posts in the cadre of superintendent and above, the Commissioner shall consult the Government before such sanction".

But, in the reference 6th cited, the post of Superintendent as abolished in the reference 4th cited has been restored in the existing cadre strength of Sri Satyamma Ammavari Temple, Ambarupeta(V) without consulting the Government, even the temple is not entitled for such post.

After careful examination of the entire matter with reference to G.O.Ms.No.183, Rev (Endts-I) Dept, Dt. 25/5/2017 and G.O.Ms.No.231, Rev(Endts-I) Dept, Dt.1-6-2023., it is decided to withdraw the orders issued in the reference 6th cited, where in the post of Superintendent as abolished in the reference 4th cited has been restored in the existing cadre strength of Sri Satyamma Ammavari Temple, Ambarupeta(V) and permission has been accorded to the Executive Officer to promote Sri S.Mohan Kumar, Senior Assistant to the cadre of Superintendent in the said post and the post of Senior Assistant in the existing cadre strength of Sri Satyamma Ammavari Devasthanam, Ambarupeta(V) has been abolished.

Accordingly, the orders issued in the reference 6th cited are hereby withdrawn as they are not in accordance with the norms fixed in the above G.Os. Consequently the superintendent post is here by

down graded as Senior Assistant.

The Executive Officer, Sri Satyamma Ammavari Temple, Ambarupeta(V) shall take further necessary action in the above matter accordingly, as per procedure.

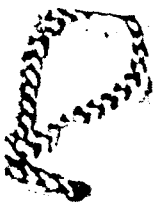

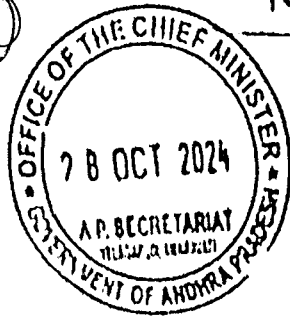



In the reference 6th cited, the Commissioner of Endowments Department, Andhra Pradesh, Gollapudi, Vijayawada has appointed as many as (5) Temple Superintendents i.e., (1) Sri U.V. Prasada Rao, Superintendent, (2) Sri J. Bhimasankaram, Superintendent, (3) Sri L.L. Srinivasa Rao, Superintendent, (4) Sri M. Radha Krishna, Superintendent & (5) Sri V. Srinivasa Rao, Superintendent working in Zone-II who are eligible for appointment as Executive Officer, Gr-I by transfer of service as per their Seniority and eligibility, subject to outcome of O.As/W.Ps pending, if any, in the subject matter.

At the time of the above appointments, the name of Sri B. Ravindra Babu, Temple Superintendent was not considered for appointment as Executive Officer, Gr-I by transfer of service, as a criminal case was registered against him in the year, 2016 and charge sheet was also filed and the same is numbered as PRC No.17/2022. The said case is still pending. Though interim orders were passed in the criminal petition filed by him before the Hon'ble High Court on 16-12-2022, staying all the further proceedings, no acquittal orders are passed to till date and his Juniors i.e., Sri M. Radha Krishna and Sri V.V. Srinivasa Rao were considered by appointment by transfer as Executive Officer, Gr-I.

A letter was addressed to Government Pleader for Endowments vide reference 7th cited for her a considered opinion to take further action regarding the request of Sri B. Ravindra Babu for appointment by transfer of service as Executive Officer, Gr-I.

In-turn the Government Pleader for Endowments has given her considered opinion vide reference 8th cited informing that the appointment by transfer as Executive Officer Gr-I, has made in the letter that at the time of considering the cases of Temple Superintendents in Zone-II for appointment by Transfer as Executive Officer, Gr-I as per seniority list, though Interim orders were passed in the criminal petition filed by the employee before the Hon'ble High Court in CrI.P. 10065 of 2022 on 16-12-2022 staying all further proceedings in PRC.No. 17 of 2022, the candidature of this employee was not considered for promotion and his juniors who are eligible were considered, as the criminal case is still pending.

She has further informed that the State Government issued G.O.Ms.No. 257, General Administration (Services) Department, dated 10-06-1999 providing certain guidelines for consideration of employees for promotion during pendency of department/Criminal Proceedings. The above guidelines issued by the State Government relaxes the interdict that the employee must be free from any criminal or departmental proceedings and permits the authorities to consider an employee for promotion inspite of pendency of Criminal case or disciplinary proceedings initiated by the department, however subject to certain conditions. As such pendency of Criminal case (PRC 17 of 2022 on the file of the Additional Judicial First Class Magistrate of Nandigama, which is stayed by the Hon'ble High Court holding that taking cognizance of an offence solely U/sec 120-B is prima facie not sustainable) cannot be a ground to deny promotion to the employee, as his case squarely comes under guidelines issued by G.O.Ms.No. 257, General Administration (Services) Department, Dt:10-06-1999.

Finally, the Government Pleader has given her considered opinion that the cases referred in G.O.Ms.No.257, Dt:10-06-1999, employee can be considered for promotion as Executive Officer, Gr-I by appointment by Transfer, in the light of above discussion, if he is otherwise qualified.



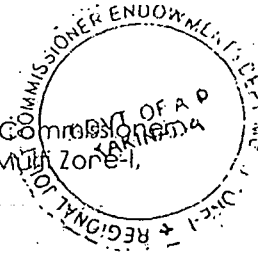



The present writ petition came to be filed under Article 226 of the Constitution of India, seeking the following relief:

2. The present writ petition is filed challenging the proceedings of the Executive Officer, Sri Satyamma Ammavari Temple, Ambarupeta Village, Nandigama Mandal, Krishna District, dated 23.03.2015 and, through which, the petitioner was repatriated to the parent temple i.e. Sri Brahmaiah Lingeshwara Swamy Temple, Chikkavaram Village, Gannavaram Mandal, Krishna District.

Later on, in the year, 2022, during the general transfers, he was transferred to Sri Yogananda Lakshmi Narasimha Swamy Temple, Vedadri Village, Jaggaiahpetta Mandal, N.T.R.District and is working in the said temple as on today. Proving which, the learned Government Pleader for Endowments has filed the

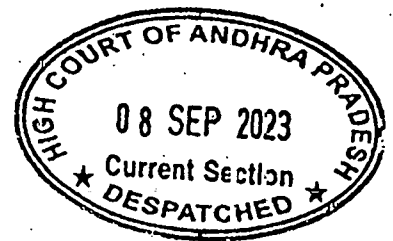

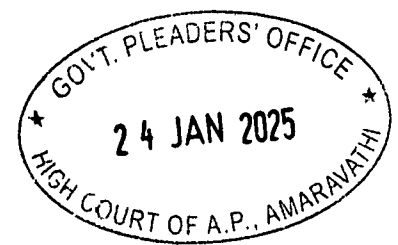
