1) I am the petitioner herein and I am well acquainted with the facts of the case.

2) I submit that, I am filing the above writ petition challenging the action of the respondent officials in not releasing death benefits such as family pension, gratuity, and other benefits of my mother died in harness

working as sweeper in the 3rd respondent devasthanam from 18.11.2022 inspite my representations dated 01.03.2023 & 23.04.2023, as illegal, arbitrary, unconstitutional, violative of the rules governing the same and contrary to Articles 14 & 300-A of Constitution of India.

3) I submit that, my mother late Smt. Pushpavathi joined the 3rd respondent temple in the year 1995 as NMR. Subsequently, in the year 2001, her services were regularized in the temple in the post of Sweeper. During her lifetime, she served in the temple to the satisfaction of the authorities and died in harness on 18.11.2022. I am the only child and daughter of my deceased mother. Hence, immediately after the death of my mother, I applied for funeral charges and the 3rd respondent released funeral charges on 07.12.2022, an amount of Rs. 25,000/- to my bank account No. 33462250008512, Canara Bank, Kanumolu branch, IFSC: CNRB0013346. My father pre-deceased my mother.

4) I submit that, my mother during her life time as she has no male child adopted my son, namely, Rakesh as her son and hence, the said Rakesh conducted the last rites of my mother. It is agreement between us that, he'll get compassionate appointment and I'll claim the death benefits of my mother. After completion of the last rites, on 01.03.2023, I submitted a representation to the 3rd respondent to release the death benefits of my deceased mother, such as family pension, gratuity, leave encashments and other monetary benefits. The 3rd respondent received the same and kept quit. On 23.04.2023, I again submitted another representation for the release of death benefits stated *supra*. But, the respondent officials having been received the same, did not take any action till date.

5) I submit that, the death benefits are rights of the dependents of the deceased employee. Employer of the deceased employee cannot delay in disbursing the death benefits as the dependents will be in dire monetary requirements on the sudden and unforeseen death of the employee. This Hon'ble Court and the Hon'ble Apex Court in catena of judgments held that, on failure or delay in the payment of the death monetary benefits, the right to interest accrues to the dependent till the date of realization of the due amounts. Hence, the inaction of the respondent officials in not paying the death benefits of my mother, is illegal, arbitrary and violative of the rules governing the same. Hence, the petition.

6) Under these circumstances stated above, the petitioner has no other efficacious alternative remedy, except to approach this Hon'ble Court under Article 226 of the Constitution of India.

7) I submit that, the petitioner has not filed any writ, suit or other proceedings before any other Court for the relief prayed herein and not such writ, suit or other proceedings are pending before any other Court of law.

It is therefore prayed that this Hon'ble Court may be pleased to issue a Writ, Order or direction more particularly one in the nature of Writ of MANDAMUS to DECLARE the action of the respondent officials in not releasing death benefits such as family pension, gratuity, and other benefits of my mother died in harness working as sweeper in the 3rd respondent devasthanam from 18.11.2022 inspite my representations dated 01.03.2023 & 23.04.2023, as illegal, arbitrary, unconstitutional, violative of the rules governing the same and contrary to Articles 14 & 300-A of Constitution of India and consequently COMMAND the

respondent official to release and pay the family pension, gratuity and other death monetary benefits to me with a rate of interest of @ 12% p.a. from the date of death of my mother till the realization of the due amounts, in the interest of justice and pass such other appropriate order or orders that this Hon'ble Court may deem fit and proper in the circumstances of the case.

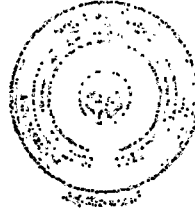

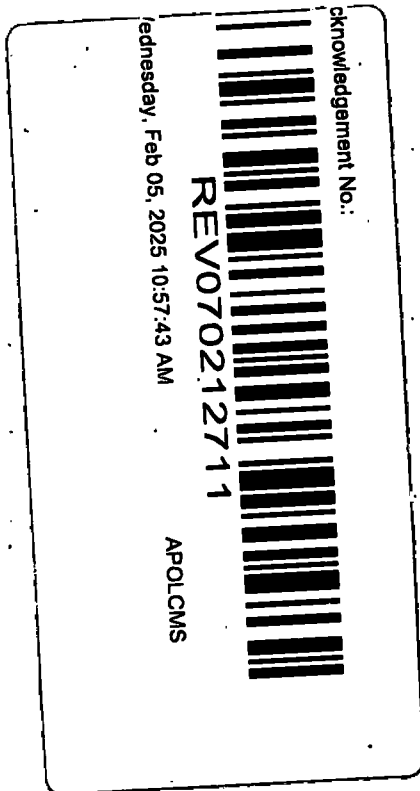
