**AFFIDAVIT**

I, Daliparthi Naga Raghavendra Rao S /o Balakoteswara Rao aged about 45 years ; occ; Employee, R/o.Bhavadevarapalli Village, Nagayalanka Mandal,Krishna District, now having temporarily come down to Amaravati, do hereby solemnly and sincerely affirm and state as follows:

1. I humbly submit that, I am the Petitioner herein and as such I am well acquainted with the facts of the case,

2. I humbly submit that the present writ petition is being filed against the impugned order vide R. C no;A1/ 45/ 2024 Dt 20-09-2024 issued by the 4th respondent where in and where by the 4th respondent removed the services of the petitioner as Bhajanthri (Sruthi) on the ground of petitioner's alleged unauthorized absence for the duties .

3. It is submits that the petitioner appointed as Bhajantri (Sruthi) on contract basis vide proceedings no A1 /58/2011 Dated 15-03-2015 issued by the then Executive Officer of the 5th respondent temple on payment of remuneration of Rs 4500/- per month . It is further submits that the then 4th respondent issued above said proceedings in pursuance of L. Dis.No.A1 /28363 /2014 dt 7-3-2015 in which the then 2nd respondent i.e commissioner endowments permitted the E .O . of the subject temple to utilize the services of the petitioner as Bhajanthri (Sruthi) . It is further submits that the petitioner worked in the subject temple with utmost satisfaction of the devotees as well as the officials with unblemished record without any stigma what so ever.

4. It is further submits that due to ill health, father of the petitioner died recently. Accordingly, the petitioner here in applied for leave from 15-05-2024 to 28-05-2024 to the then E.O with a view to complete final rituals such as "Pindapradhanam" at Kasi, Gaya and other holy places. Thereafter, the petitioner also fell in ill health and stayed in his in-law's house. It is further submits that the petitioner never received any communication what so ever from the respondent authorities. Subsequently the petitioner went to the temple where he is working, to his utter shock and dismay came to know about impugned order removing the petitioner from service.

5. It is further submits that there after the petitioner here in made representation on 13-10-2024 to the 5th respondent by duly explaining above said facts. The petitioner also enclosed medical certificate along with representation in which concerned Associate Professor advised the petitioner to take bed rest for a period of 4 months 15 days from 30-05-2024 to 12-10-2024. Therefore the petitioner here in applied for leave for the above said period and above said fact clearly goes to shows that nothing wrong on the part of the petitioner. It is further submits that allegation of unauthorized absence of the petitioner for duties is not true and correct. It is for the respondents to issue notice to the petitioner immediately, if the petitioner unauthorizedly absent for duties but not on 21-06-2024 that too after lapse of more than one month. Infact as per the honble Supreme Court's Judgement in a departmental proceeding, if allegation of unauthorized absence is made, the disciplinary authority is required to prove that the absence is wilful, in absence of such finding, the absence will not amount to misconduct. It is further submits that admittedly the petitioner here in never received alleged notice dt

21-06-2024 .In view of the same case of the petitioner solely stands on violative of principles of natural justice and without following due process of law . Hence any consequential orders passed there on is absolutely not sustainable either in law or facts of the case and impugned order is liable to be set aside by this Honb'le court .

6. It is further submits that in the impugned order dt 20-09-2024 issued by the 4th respondent it was stated that through notice dt 04-03-2023 three charges have been framed against the petitioner and suspended. It is further submits that said fact is absolutely wrong. As per the said notice dt 04-03-2023 second charge is that the petitioner while taking salary from the 5th respondent temple, worked in SriBhavannarayana Swamy temple Bhavadevarapalli. The above said charge is absolutely baseless in terms of the letter addressed to the then 5th respondent by the then above said temple E.O dt 19-4-2023 as the same is clarified that the petitioner is not working there. Even notice Dt 04-03-2023 issued with a mala fide intention in a mechanical manner without application of mind with a view to harass the petitioner. The other two charges in the above notice also are vague. Inspire of the same, the 4th respondent referred the same in the impugned order is nothing but ill motive on the part of the then 4th respondent . It is further submits that specific case of the petitioner is that the then 4th respondent with a mala fide intention did all these things which including issuance of impugned order .The said action on the part of the respondents more particularly the 4th respondents highly illegal , arbitrary ,unconstitutional and violative of article 14 and 16 Of the constitution of India .

7. It is further submits that as stated earlier, the petitioner never received any alleged notice and subsequent impugned order. In that view of the matter the order under challenged was not issued in a due process. in other words while passing impugned order, no opportunity was given to the petitioner. Therefore, it is just and proper to direct the 4th respondent to re consider the case of the petitioner afresh in order to disprove his case. Even assuming that charges against the petitioner proved, maximum punishment of removal from service cannot be imposed as the petitioner never involved in financial irregularities and accordingly the impugned order dt 20-09-2024 is liable to be set aside by this honble court.

8. In the circumstances stated above, the petitioner has no efficacious alternative remedy, except to seek the redressal before this Hon'ble Court seeking the indulgence of this Hon'ble Court to exercise the extraordinary original jurisdiction vested in this Hon'ble Court by virtue of Article 226 of the Constitution of India. The petitioner has not filed any writ petition, suit or other proceedings for the relief or relieves sought herein.

It is therefore prayed that this Hon'ble Court may be pleased to issue order more particularly one in the nature of writ of mandamus declaring the impugned order vide R.C .noA1/45/2024 Dt 20-09-2024 issued by the 4th respondent in removing the petitioner from service as Bhajanthri (Sruthi) as violative of principles of natural justice and also illegal arbitrary, unconstitutional and, violative Article 14 and 16 of the constitution of India and consequently set aside the same and pass such other order or orders may deem fit and proper in the circumstances of the case.



It is also just and necessary that this Honble Court may be pleased to suspend the impugned order vide R.C .noA1/45/2024 Dt 20-09-2024 issued by the 4th respondent in removing the petitioner from service as Bhajanthri (Sruthi), pending disposal of the above writ petition and pass such other order or orders may deem fit and proper in the circumstances of the case.

It hereby informs you that the temple of Sri Subrahmanveshwara Swamy in Mopidevi, D. Naga Raghavendra Rao, the Shruti instrumentalist, has been temporarily removed from duties by this Office Notice Dated 04.03.2024 by dated 04.03.2024 on three (3) charges framed against you by as Cited in Reference 1. The letter sent by you on 01/2023 was first wrongly forgiven and requested to be returned to the subsistence job. Subsequently, the charges against you were kept pending and you were reinstated, but there seemed to be no change in your Behavior.

Further, without informing the Executive Officer in advance and without obtaining any permission, an explanation should be given for dereliction of duty for not attending duties for 40 days up to 12/05/2024 to 20.06.2024. As Cited in Reference 2

dated 21/06/2024 We take seriously your delay in giving any reply so far without giving any reply on the notice sent by the registered post. Even now, as on 30/07/2024, more than 80 days of not attending to duties and not attending to duties for more than 80 days, you have been absent from the duties and your attitude towards the officers and your duties has been recognized as the most serious act. We have not seen any change in your behavior despite being reprimanded several times in the past.

Subsequently, the investigating officer has given a report that two of the three charges levelled against you in the past have been proved.

Therefore, since you are two of the three charges charged against you on 04/03/2023 and on the notice sent by registered post on 21/06/2024 i.e. 98 days as on 18/08/2024, As on 18/08/2024, you have been permanently removed from the duties of Shruti instrument at Subramanyeswara Swamy's devasthanam, Mopidevi, as the official article has shown a negligent attitude towards the authorities and the authorities without giving any reply for not attending to the duties even though it is 98 days as on 18/08/2024.



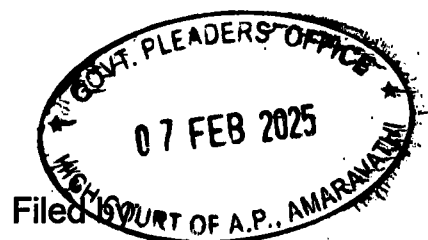
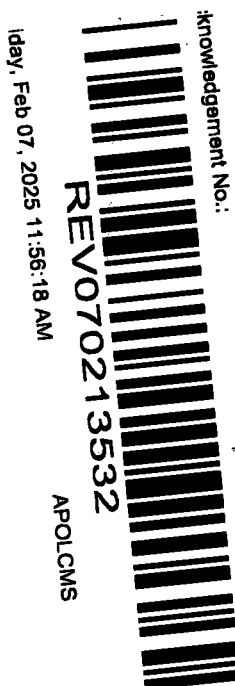
