

1. I am the petitioner herein and as such I am well acquainted with the  
facts of the case.
2. It is humbly submitted that, the present writ petition is filed challenging  
the action of the 3<sup>rd</sup> respondent in not refunding the EMD (Earnest

Money Deposit) of Rs.4,00,000/- i.e. Rs.2,00,000/- each to the petitioner paid towards supply of manpower and for housekeeping & sanitation respectively paid at the time of participation in auction on 17.03.2023 conducted by 3<sup>rd</sup> respondent as bad illegal arbitrary and violative of Articles 14, 21, 25 and 300-A of Constitution of India.

3. I submit that, the 3<sup>rd</sup> respondent temple has issued auction notification 28.01.2023 for conducting license hold rights of various licenses including supply of man power and sanitation. Thereafter auction was postponed and auction notification was issued 14.02.2023, finally on the 3<sup>rd</sup> attempt auction notification was issued on 02.03.2023 and the auction was held on 17.03.2023. In the said auction I have become highest bidder for two licenses supply of manpower and maintenance of sanitation and housekeeping in the 3<sup>rd</sup> respondent temple.
4. I submit that, at the time of auction, I have paid EMD of Rs.2,00,000/- each for supply of manpower and housekeeping & sanitation totaling Rs.4,00,000/- vide DD No's. 618894 dated 13.03.2023 and 618895 dated 13.03.2023 drawn on SBI, Kasapuram. Thereafter my license was approved for sanitation & housekeeping by the 2<sup>nd</sup> respondent vide proceedings in L.Dis No. D2/COE-14026(34)/31/2023 dated 13.06.2023.
5. I submit that, while the matter stood thus one temple employee namely NKS.Krishna Reddy working in the 3<sup>rd</sup> respondent temple as Security Supervisor was caught committing theft of hundi and he was suspended, taking the same into consideration my license was cancelled alleging that I am the binamee of the said Krishna Reddy from September, 2023.
6. I submit that, now my grievance is my tender may be cancelled but my EMD lying with the temple totaling Rs.4,00,000/- have to be

refunded and the same are not refunded, as such I have submitted representations on 03.04.2024, seeking refund. Even after lapse of around 8 months my amount is not refunded. I have even sent a legal notice on 29.04.2024 seeking refund of my EMD but as on today no action is taken. Hence the present writ petition is filed.

7. I submit that, without conducting enquiry, without giving notice, without affording opportunity to me and without allowing me to adduce oral evidence, abruptly my license is cancelled and my EMD is not refunded. I have not claimed any continuance of license, but only claimed refund of EMD by submitting representations, but as on today no action is taken. Unless my EMD is refunded I will be put to irreparable loss and injury which cannot be compensated by any means. Hence the writ petition.
8. It is submitted that the petitioner has no other alternative and efficacious remedy except to approach this Hon'ble Court under Article 226 of constitution of India.
9. It is submitted that the petitioners have not filed any suit, application or petitions before any court of law and we have not sought for any similar relief.

In the above mentioned circumstances, It is therefore prayed that this Hon'ble Court may be pleased to issue a writ order or direction more particularly, one in the nature of Writ of Mandamus, declaring the action of the 3<sup>rd</sup> respondent in not refunding the EMD (Earnest Money Deposit) of Rs.4,00,000/- i.e. Rs.2,00,000/- each to the petitioner paid towards supply of manpower and for housekeeping & sanitation paid at the time of participation in auction on 17.03.2023 as bad illegal arbitrary and violative of Articles 14, 21, 25 and 300-A of Constitution of India and consequently direct the 3<sup>rd</sup> respondent to

Under the instructions from our Client Y.Siva Reddy S/o Y.Muni Reddy, Manpower Supply (Pavan Security Services) resident of Guntakal, Ananthapuramu Dist, A.P., we are issuing the following notice to you.

That as per your Advertisement in Andhra Jyothi Daily News Paper dated 03.03.2023 called through E-procurement-Sealed Tenders for Skilled and Unskilled workers amounting to 71 persons on outsourcing basis to work in the Temple and to supply the same, our client submitted Tender for the above said works for the period from 01.04.2023 to 31.03.2024. As per the terms and conditions of Tender, our client submitted the concerned relevant documents along with Demand Draft for Rs.2,00,000/- drawn on State bank of India, Kasapuram Branch bearing No.618894, dated 13.03.2023 towards EMD amount. That the above Tender submitted by our client was under scrutiny, the Hon'ble Commissioner, Endowments Department, Vijayawada has not accepted the same and cancel the said Tender.

While that is so, one N.K.S. Krishna Reddy, Security Supervisor of Temple was caught hold of committing theft of cash from the Hundi on 17.09.2023 and the same was proved on perusal of CC Cameras and he was suspended from his duties. That it has been alleged that the said N.K.S. Krishna Reddy is the relative of our client and our client is his Benami and as such the then Temple authorities have cancelled the Tender of our client. Since from the month of September 2023 the Devasthanam Officials have paid salaries from the months of September 2023 for seven persons. That the Tender which was submitted by our client was expired on 31.03.2024.
