

I, Ch. Rangarao, S/o Ch. Nageswara Rao, Aged about 39 years; Occ: Assistant Commissioner / District Endowments Officer, Endowments Department, Eluru, Eluru District (erstwhile West Godavari District), and temporally came down to Amaravathi do hereby solemnly and sincerely affirm and state on oath as follows.

2) It is submitted that I am working as the Assistant Commissioner, Endowments Department, Eluru of Eluru District and that I am the 3rd respondent herein and as such well acquainted with the facts of the case. I have read and understood the averments mentioned in the affidavit of the petitioner filed in support of the writ Petition and I deny all the material

averments made in the affidavit except those that are specifically admitted hereunder and those that are not contrary to the records. The petitioner is put to strict proof of the same.

3) It is submitted that the petitioner filed this present writ petition for an order one in the nature of writ of mandamus declaring the action of the respondent authorities in proposing to conduct the auction of the lands in R.S Nos.160 and 161 corresponding to new R.S.Nos.170 and 171 situated at Sriramavaram village Denduluru Mandal West Godavri District (now Eluru District) without any manner of right authority or claim whatsoever as illegal and arbitrary. This writ petition is not maintainable either on facts or in law.

4) It is submitted that this writ petition is bad for non-joinder of proper and necessary party as the petitioner did not implead Sri Sitarama Swamy Temple, Sriramavaram represented by Single Trustee to which the subject property of this case belongs. In the absence of the above temple as one of the respondents in this case, the rival issue involved in this case may not be adjudicated effectively and consequently. On this ground alone, this writ petition is liable to be dismissed in limine.

5) It is further submitted that Sri Sitarama Swamy Temple Sriramavaram (herein after mentioned as "the subject temple") was published U/s 6 (c)(ii) of the Act 30/87 and the same is under the administrative control of the 3rd respondent herein. The subject temple was registered U/s 43 of the Act of 30/1987 and the same approved by the 3rd respondent vide Rc.No.A3/5527/2020, Dt:26.11.2021, as per approved registered of the subject temple maintained U/s 43 of the Act, the subject temple owns the subject land of this case as the same was gifted to the temple vide Doc.No.643/1919, Dt:24.06.1919 of S.R.O, Bhimadole, West Godavari District. The petitioner herein filed W.P.No.28588 of 2021 challenging publication of the subject temple herein. After hearing, the Hon'ble Court allowed W.P.No.28588/2021 on 31.01.2022 setting aside publication

proceedings Dt:24.04.2021 leaving it open to the respondents to take appropriate steps after duly following the procedure set out by this court in its order Dt:22.11.2021 in W.P.No.10283/2021. Wherein, this Hon'ble Court held that first the institution has to be registered U/s 43 of the Act 30/1987 and thereafter has to be published U/s 6 of the Act by due procedure.

6) It is further submitted that in pursuance of orders of this Hon'ble Court in W.P.No.28588/2021 Dt:31.01.2022, the 2nd respondent – Commissioner of Endowments Department has taken steps as per procedure afresh and issued proceedings in R.Dis.No.J1/169/2025, Dt:11.04.2025 publishing the subject temple U/s 6 (c)(ii) of the Act 30/1987 as already the subject temple was registered U/s 43 of the Act and the same was approved by the 3rd respondent as per procedure known to law.

7) It is further submitted that one Sri Kamireddy Nagaiah, S/o Kamireddy Daramaiah who is great grandfather of the petitioner, has gifted the subject landed property of this case to the subject temple by execute a registered gift deed mentioned above in the year 1919 for Doopa Deepa Naivedyam to the Deity and for remuneration to Archakas for rendering Archakatvam. Wherein, it is specifically mentioned that if for any reason, his successor of Kamireddy family failed to look after maintenance of the subject temple, the subject temple has to be handed over to the Endowments Department. The successor of the donor - Kamireddy Nagaiah failed to look after the maintenance of the subject temple and as such, the subject temple was published and registered under the provisions of the Endowments Act. But the subject temple was under private management till appointment of Single Trustee by the Deputy Commissioner, Endowments Department, Kakinada. Since the subject temple is duly registered U/s 43 of the Act of 1987, the said temple is under Administration and Management by Single Trustee.

8) It is further submitted that while the matter stood thus, one Kamireddy Naga Venkata Sujatha, W/o Surya Bhaskara Rao R/o Sriramavaram (V), who is a close relative of the writ petitioner herein, filed W.P.No.22767/2021, for a



direction to the official respondents therein to protect and to conduct public auction for lease hold rights of subject landed property of the case belonging to the subject temple. Subsequently, the writ petitioner herein was impleaded as 6th respondent in W.P.No.22767/2021. Later, the Single Trustee of the subject temple has taken steps for mutation of name of the subject temple basing on the gift deed, in Revenue records and submitted an application accordingly to the concerned M.R.O and the same is pending. Smelling the same, the writ petitioner filed the present Writ Petition as if the respondents herein are going to conduct the public auction for lease hold rights of the lands in R.S.Nos.160 & 161 (new R.S.Nos.170 & 171) situated at Sriramavaram (V) belonging to the subject temple.

9) It is further submitted that the writ petitioner is fully aware that either the Government or the Commissioner of Endowments or the Assistant Commissioner of Endowments i.e., respondents 1 to 3 herein are not used to conduct public auction for lease hold rights of landed properties of an institution and that only the Executive Authority / Single Trustee of an institution used to lease out the properties of the institution by way of public auction as per procedure. If really the alleged cause of action mentioned by the petitioner in this case is true and correct, the petitioner ought to have implead the subject temple represented by Single Trustee as one of the respondents in this case. But he did not do so for the reasons best known to him. In fact respondents 1 to 3 herein are not taking any steps to conduct auction for lease hold rights of lands covered by R.S.Nos.160 & 161 of Sriramavaram (V) belonging to the subject temple.

10) It is respectfully submitted that the petitioner is in possession and enjoyment of subject lands of this case belonging to the subject temple without any right and title whatsoever and that the petitioner is liable to pay damages to the subject temple for unauthorized use and occupation of the temple lands and that the petitioner shall be vacated by way of procedure as

contemplated U/Sec.83 of the Act of 1987 and then only the public auction in respect of the said lands should be held by the concerning authority.

11) It is humbly submitted that no cause of action arose to the petitioner to file the present writ petition by invoking writ jurisdiction under Article 226 of the Constitution of India. The alleged cause of action mentioned in the petition is created for the purpose of filing the present case. No writ is maintainable on the assumptions of the petitioner. Hence, this writ petition is liable to be dismissed for want of cause of action.


12) It is further submitted that no prima facie case is made out by the petitioner in support of the reliefs as prayed for in this case. Consequently this writ petition is liable to be dismissed for want of merits.

In view of the above facts and circumstances, it is, therefore, prayed that this Hon'ble Court may be pleased to dismiss the writ petition as devoid of merits and pass such other order or orders as this Hon'ble Court may deem fit and just in the circumstances of the case to meet ends of justice.

TRANSLATION FROM TELUGU VERTSIION TO ENGLISH

REGISTERED GIFT PATTA DATED 26.04.1919 BEARING DOCUMENT
NUMBER 643/1919

The gift patta (Dharma-Patta) executed and made arrangements permanently to conduct Doopa, Deepa, Naivedyamulu (Daily Poojas) to Sri Sita Rama Swamy with an amount of Rs.150/- (Rupees One Hundred and Fifty only) for every year.

Every year festival to the swamy will be conducted by me and accordingly I agree. As per the terms of this deed myself and my issues do not conduct the above ceremonies this secured property without any recourse to separate document the property is handed over to the swamy and we relinquish our trustee ship. To implement the above terms in respect of swamy our villagers 1.Kamireddy Somaiah, 2.Alla Ramaiah and their issues should take care. The details secured property. III.
