

AFFIDAVIT

I, Kallaluri Kameswara Rao, S/o. Kundaleswarudu, Age 54 years, Occ: Hereditary Archaka, R/o. 1-24, Kundaleswaram, Amalapuram, DR. B.R.Ambethkar Konaseena District, having temporarily come down to Vijayawada do hereby solemnly affirm and sincerely state on oath as follows:

1. I submit that, I am the 1<sup>st</sup> petitioner and deponent herein, as such I am well acquainted with the facts of the case. I am authorized to swear on behalf of other petitioners also.
2. It is submitted that the present writ petition is filed challenging the action of the respondents in proposing to install hundials in the 5<sup>th</sup> respondent temple as bad, illegal and arbitrary and violative of articles 14, 21, 25 & 26 of Constitution of India.

3. I submit that, we all hail from the hereditary archaka family of the 5<sup>th</sup> respondent temple and we are all hereditary archakas. The total land belonging to temple measuring Ac. 20.04 cents was cultivated by the archakas i.e. our forefathers towards their remuneration. There was no other source of income to the temple except income from these lands and there were no hundials or sale of tickets.
4. I submit that, there arose a dispute between the trustees and archakas, as such a compromise was entered and executed before the then Commissioner, Endowments Department vide proceedings in D.Dis No. 15252/61-03 dated 18.02.1966 as per the compromise order the lands were shared as follows:

5. I submit that, from the date of compromise the archakas are enjoying the lands and rendering archakatvam without any hindrance. There are no hundials in the temple from the date of construction till today, all of a sudden the respondent 2 to 5 are proposing to install hundials in the temple on the eve of Mahasivaratri i.e. on 26.02.2025 and they were started measuring the places in the temple from 22.02.2025 to install the hundials. Hence challenging the proposal of respondents to install the hundials the present writ petition is filed.
6. I submit that, there are no notice, no orders but all of a sudden decision is taken for installing the hundials in the 5<sup>th</sup> respondent temple. As on today total there are 19 hereditary archakas rendering archakatvam on rotation basis. All these archakas are living on the income generated on the Ac. 5.50 cents and plate collection. Even the paditaram expenses of Rs.5,000/- + nandadeepam expenses of

Rs.500/- totaling Rs.5,500/- per month is also not paid for the past 3 years by the E.O.. The income generated on the temple share land of Ac.15.54 cents is around Rs.3 lakhs to Rs.3.5 lakhs and the same is taken away by the Executive Officer.

7. I submit that, if the Ac. 5.50 cents is divided into 19 parts each archaka will get only Ac.0.28 cents toward their share. The only source of livelihood is plate collection. Hence if the hundials are installed and tickets are sold our livelihood will be knocked away and we will not be able to eak livelihood.
8. I submit that, as per Sec. 144 of Act 30/87 the shares in hundials and other rusums are abolished. The said provision is not made applicable to the temple having income less than Rs.5 lakhs, further even if the income is more than Rs.5 lakhs, a scheme has to be framed till such time the existence system has to be continued. The relevant provision extracted for the kind perusal:

"Provided that the above said provision shall be applicable only for those institutions who annual income as defined under Sec.65 exceeding Rs.5 lakhs per annum:



9. I submit that, without framing the scheme the existing system cannot be disturbed. In the instant case the source to temple is from the Ac. 15. 54 cents of land belonging to temple. Hence the income is below Rs.5 lakhs, even the E.O. is collecting the arrears only once 3 years for the past several years but he want to install a hundi. The temple is a 6 (c) institution. All the kalyanams and festivals are organized performed by the archakas by searching for donations etc.,
10. I submit that, the Govt. has also issued a GO 298 dated 06.07.2023 taking a decision to hand over the temples having income below Rs.5 lakhs to the archakas. In the instant case there are no hereditary trustees and there are only hereditary archakas, as such temple management has to be handed over to the archakas instead of handing over the temple, now the steps are being taken for installing the hundis. We have also submitted representations on 26.03.2024 to handover the temple, as per the above GO but no action is taken as on today. Hence challenging the same the present writ petition is filed.
11. I submit that, we have submitted representations dated 21.02.2025 not to install the hundis and not to start sale of tickets, without framing a scheme and granting 50% share to the archakas in the hundis and tickets as per Sec. 144 of Act 30/87 by framing a scheme. As we are the recognized hereditary archakas as per Sec. 34 (3) of Act 30/87 and are eaking livelihood on the Heriditary archakatvam only.
12. I submit that, there is an urgency in the matter for granting interim orders otherwise we will be put to irreparable loss and injury which cannot be compensated by any means.

13. It is humbly submitted that, the petitioner has no other alternative and efficacious remedy except to approach this Hon'ble Court under Article 226 of constitution of India.
14. It is submitted that the petitioner has not filed any suit, application or petitions before any court of law and I have not sought for any similar relief.

In the facts and circumstances mentioned above, it is therefore prayed that this Hon'ble Court may be pleased to issue an appropriate writ, order or direction, more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in proposing to install hundials and sale of tickets in the 5<sup>th</sup> respondent temple as bad, illegal and arbitrary and violative of articles 14, 21, 25 & 26 of Constitution of India and consequently direct the respondents not to install hundials and sale of tickets without framing scheme as per Sec. 144 of Act 30/87 and pass such other order or orders in the interest of the justice.

Pending disposal of the writ petition, it is therefore prayed that this Hon'ble Court may be pleased to direct the respondents not to install hundis and start sale of tickets in the 5<sup>th</sup> respondent temple and pass such other order or orders as this Hon'ble Court may deem fit and proper.

అతి పురాతనమైన ఎంతో చరిత్ర కలిగిన దేవాలయము, సదరు దేవాలయముతో పూర్వం నుండి వంశ పారంపర్య అర్చకులుగా కొనసాగుతూ వచ్చు చున్నాము. సదరు దేవాలయమునకు 20 యకరముల 50 సెంట్లు భూమి కలదు. పూర్వ కాలంలో మా పెద్దలే ఆ భూమిపై వచ్చే ఆదాయముతో ధూపదీప నైవేద్యములు, ఉత్సవములు జరుపుకుంటూ సర్వీసు చేసుకొంటూ వచ్చియున్నారు. 18-02-1966 సంవత్సరంలో డిపార్టుమెంటు వారు భూమిని స్వాధీన పరచుకొని కాంప్రమైజ్ ఆర్డర్ నెంబరు D. Dis No. 15252. 61-C3, dated 28.02.1966 ద్వారా అర్చక సర్వీసు ఈనాముగా 5 యకరముల 50 సెంట్లు భూమిని మా అర్చకులకు ఇచ్చి యున్నారు. మిగిలిన భూమి డిపార్టుమెంటు వారి వద్దనే యున్నది. స్వామి వారి మహానివేదన నిమిత్తము (పడితరము) రూ.60,000/- చొప్పున సంవత్సరమునకు ఇచ్చు చున్నారు. అదే విధంగా నందాదీపము నిమిత్తం నెలకు రూ.500/-లు చొప్పున ఇచ్చుచున్నారు. సదరు పడితరము, నందాదీపము నిమిత్తము రొక్కం 3 సంవత్సరముల నుండి బకాయి యున్నవి. మా దేవాలయము 6సి కేడరుగా ఉన్నది. మాకు ఇవ్వవలసిన బకాయిని ఇ.ఒ. గారిని అడుగుతుంటే రైతులు శిస్తు బకాయిలు పెట్టియున్నారు. సుమారు 4, 5 సంవత్సరముల నుండి వసూలు కావట్లేదు అని అవి వచ్చిన తరువాత మీకు ఇవ్వగలను అంటున్నారు. అయితే ఈ మధ్య కాలంలో దేవాలయములో నూతనముగా హుండీలు ఏర్పాటు చేస్తాము అని ఇ.ఒ. గారు, ఇన్ స్పెక్టరు గారు అంటున్నారు. ఇంత వరకు ఈ దేవాలయములో ఎటువంటి హుండీలు లేవు. మా దేవాలయ ఆదాయము 5 లక్షల లోపు మాత్రమే ఉన్నది. ఏవిధముగా అంటే దేవస్థానంవారి వద్ద యున్న భూమి పాటల ద్వారా వచ్చే శిస్తు సుమారు సంవత్సరమునకు సుమారుగా రూ. 3,60,000/- దాకా వచ్చుచున్నది. ఇతర ఏవిధమైన ఆదాయ వనరులు లేవు. అయితే ఈ సంవత్సరం పాత బకాయి కొంత వసూలు చేసి 5 లక్షల ఆదాయం దాటించని చెప్పుచున్నారు. 33/2007 ఎండోమెంట్ నవరణ చట్టం అనుసరించి సెక్షన్ 34 (3) ప్రకారం 5 లక్షల రూపాయలోపు ఆదాయం యున్న దేవాలయమునకు సెక్షన్ 144 వెసులుబాటు యున్నది. నిజముగా వరుసగా 3 సంవత్సరములు 5 లక్షలు పైబడి దేవాలయము ఆదాయము దాటి ఉన్నా, ఆ దేవాలయములో స్కీము అవలు చేయాలి. సదరు విషయములన్నీ పరిశీలించి మాకు సరైన న్యాయం చేయమని కోరుకుంటూ ఒకవేళ నూతనముగా ఉండి ఏర్పాటు చేసినా, టిక్కెట్లు పెట్టినా అందు 50% రుసుము పారితోషికముగా మాకు ఇప్పించవలసినదిగా కోరుచూ మా సంఘ పెద్దల సూచన మేరకు జిల్లా మహారాజశ్రీ డి.ఇ.ఓ. గారికి, 26-3-2024వ తేదీన దరఖాస్తు చేసుకొంటిమి. దానిపై ఇప్పటివరకు ఎటువంటి సమాచారమూ లేదు.

I, as the hereditary priest of Sri Kundaleswara Swamy Temple, situated in Kundaleswaram Village, Katrenikona Mandal, Konaseema District, humbly submit my request.

Subject: Request for Installation of New Hundi (Donation Boxes) in the Temple

Dear Sir,

Our temple, which has a rich historical background, has had hereditary priests serving for generations. The temple has 20 acres and 50 cents of land. In the past, my ancestors used the income from this land for offering dhupa, deepa, naivedya, and conducting festivals while serving the temple. On 18th February 1966, the Department acquired the land, and through Compromise Order No. D. Dis No. 15252.61-C3, dated 28th February 1966, the Department allocated 5 acres and 50 cents of land to our family for priestly services. The remaining land is still under the Department's possession. For the Lord's worship (Paditharam), the Department provides an annual amount of Rs. 60,000. NOTIFICATION

In exercise of the powers conferred under section 154 of the Andhra Pradesh Charitable and Hindu Religious institutions and Endowments Act, 1987 (Act No.30/1987), the Government of Andhra Pradesh hereby grant exemption to the temples having assessable income of less than Rupees Five lakhs per annum, from the operation of the following provisions of the Andhra Pradesh Charitable and Hindu Religious institutions and Endowments Act, 1987, for a period of five years:

- Section 15: (appointment of Board of Trustees) to the Temples, where there is a Founder / Member of Founder's Family or where the Temple is under the administration of reputed Religious organization.
- Section 29: (appointment of Executive Officer) to the Temples, where the Founder / Member of Founder's Family or Hereditary Archaka or reputed Religious organization in the order of preference, wants to manage the Temples by themselves.

[1]

- iii. Section 57: (submission of budget and payment of Common Good Fund) and
- iv. Section 65: (Liability to pay annual contribution to Endowment Administrative Fund and Audit Fee).

**Subject to the following conditions:-**

1. These exemptions shall not apply to the temples covered either under the Ancient Monuments and Archaeological Sites and Remains Act, 1958 (Central Act No.24 of 1958) or under the Andhra Pradesh Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1960 (Andhra Pradesh Act No 07/1960).
2. The prevailing traditions of pooja vidhanam, customs and sampradayams of the respective Temples shall not be disturbed and same shall be strictly followed.
3. New appointments of any kind, without obtaining prior permission of the Commissioner of Endowments are strictly prohibited. Commissioner can also accord permission to engage staff on outsourcing basis alone.
4. No immovable or movable properties shall be transferred except as per the provisions of section 80 of the A.P. Charitable and Hindu Religious Institutions and Endowments Act, 1987 (Act No.30 of 1987).  
  
"Transfer" means any sale, gift, exchange, mortgage with or without possession or any other transfer of endowed lands and includes a charge on such property or a contract relating to endowed lands in respect of such sale, gift, exchange, mortgage or other transaction.
5. The landed properties shall be protected from illegal sale, mortgage, exchange, unauthorized lease / license and encroachment.
6. All the properties of such temples shall be entered in section 43 register of the Temple and it shall be ensured that they are included in the prohibitory list maintained by the Registration Department under section 22-A(1)(C) of the Registration Act, 1908.
7. No lands or shops of the Temple shall be given for lease / license for more than three (3) years. All leases of shops, lands and other licenses shall be by way of only public auction and approval from the competent Authority shall be mandatorily obtained as per Rules.
8. No FDRs shall be encashed without the prior approval of the Commissioner under any circumstances.
9. No structural changes shall be made either within the Temple prakaram or abutting the temple prakaram without obtaining prior approval from the Commissioner of Endowments.
10. If any illegality or irregularity is identified in the administration of the Temple, the Commissioner shall initiate action as per the provisions of the Act.

During the enquiry in the presence Leaders of Archaka Samaikya, and the Executive Officer of the subject temple who attended the enquiry has informed that on perusal of property register approved U/s 43 Repealed Act, and Archakas filed affidavits, Archaka Compromise order of Sri Kallakuri Bapeswara Sharma and 18 others are working as Archaka in the temple and they are used to rendering archakatwam service in the temple enjoying service Inam land on rotation basis for a period of 6 months. According to particulars submitted by the Executive Officer of the subject temple, 19 members are working on rotation basis for every year. The term of 1st share holder will comes after 18 years and they enjoying the temple land without rendering service on the plea that their turn will comes after 18 and This is against the principal of allotment of service Inam of the object for rendering archakatwam service.
