

I submit, that, while things stood thus, I was made an application/representation/Legal Notice dated 09-04-2023 to the 2nd respondent, requested in the following manner:-*"Sri Ainavilli Vigneswara Temple located in Dr.B.R.Ambedkar Konaseema District under your jurisdiction, all types of Sevas, Abishekam and worships performed, tickets issued by Devasthanam were performed by Sri Kappagantula Sri Rama Murthy disciples, he offered his services to the Temple for nearly 50 years and served as Alaya Purohit, Alaya Brahma, he used to live with the concept given by the Devotes, the income on the Seva Tickets and fee for various was taken by the Government, Sri Rama Murthy Garu was paid his respectable remuneration once in a year in the form of vouchers, the service to be done for various Seva Tickets were performed by Sri Kappangantula Rama Murthy garu in this issues, service was done by him whereas amount obtain the tickets taken by the Government, on 17-12-2019 my*

I submit, that, though, I am the only person applied for said Purohit in the 4th respondent Temple as the said *Sri Kappangantula Rama Murthy garu* family members were not interested to do this Purohit Services, therefore, though I am having requisite qualifications as I was obtained a Certificate of **“Samartha Vidyayoitha”** from Sri Satya Deva Veda Sastar Smartha Agama Pathasala i.e., Sri Satyanarayana Swamy Devsthnam, Annavaram(Erstwhile East Godavari District) I am poor Brahmin Family and eking out my livelihood by rendering Archakatvam Seva, therefore, the action of the 2nd respondent in not considering application/representation/Legal Notice dated 09-04-2023 to the 2nd respondent, is nothing but illegal, arbitrary and violation of Fundamental Rights under the Constitution of India.

5. I submit, that, in pursuance of my application/representation/Legal Notice
