AFFIDAVIT

I, Gangireddigari Narayana Reddy, S/o. Gangireddigari China Obi Reddy, age 72 years, R/o. Chillavari Palli village, Tadimarri Mandal, Ananthapuram District, having temporarily come down to Amaravati, do hereby solemnly affirm and sincerely state as follows:

1. I am the Petitioner herein and I know the facts of case.

2. The above writ petition is filed questioning the action of the respondents in issuing GORt No. 145 dated 24-02-2025 against 5th respondent temple to take over management of 5th respondent Temple from the village elders committee of the temple to the Endowment department without any notice is illegal, arbitrary and violative of principles of natural justice.
3. I submit that Sri Katakoteswara Swamy Temple situated at Chillavaripalli village of Tadimarri madnal is an old temple and the same was constructed by my ancestors and the same is being in dilapidated condition and we decided to mobilize funds to renovate the above said temple long back. I submit that my great grand fathers affixed the copper plate engraving my ancestors name i.e. RAGI SASANAM in the said temple.
4. I submit that my ancestors also donated the land admeasuring to the extent of Ac. 5-22 cents in survey No. 28 of Chillavari palli village, Tadimarri mandal and the same was disclosed in pahanies with respect to the name of temple as pattadar and our names shows as possessor and enjoyer of the subject temple land in the concerned revenue records.
5. I submit that the village elders called for a pachayat and resolution was also passed when there are family disputes with regarding performing pujas in the said temple that I have to be continued to perform prayer in the said temple as usual and the same was supported by number of local authority people, but the 2nd respondent took the custody of the temple and handed over to the executive officer along with entire records for the reasons best known to them.



6. While that being so, the third parties illegally entered into the temple and occupied the subject temple. Therefore I was forced to approach the Hon'ble Tribunal against the 3rd parties high handed action in OA No. 137 of 2016 on the file of AP Endowment Tribunal, Amaravati and the same is pending even this Hon'ble Court directed to dispose of the case as expeditiously within a period of three to six months from the date of receipt of copy of the order in WP No. 42654 of 2018 by order dated 27-11-2018, but the Hon'ble Tribunal not disposed of the same as per direction of this Hon'ble Court for the reasons best known to it.
7. I submit that the Archaka was forced to request my grievance before the Executive Officer etc for the last several years against my innocence and finally submitted representation requesting to consider to take into duties as Archaka by taking undertaking in future not to resort to put in dispute of the subject, but not received any communication for my grievance. I submit that the respondent ought to have convene to resolve the issue by giving any alternative, but they have sat spectators in the subject issue.
8. While that being so, the respondents without any enquiry and giving opportunity into the affairs, the 1st respondent issued proceedings dated 24-02-2025 to keep committee from functioning without any remarks against the committee simply fighting for our rights over the subject temple. The action of the respondents in issuing proceedings is illegal, arbitrary and violative of principles of natural justice.
9. I submit that I have no other alternative remedy except to approach this Hon'ble Court under Article 226 of the Constitution of India. I have not filed any Writ Petition or initiated any proceedings in any other court of authority praying the same relief.

10. In the above circumstances, it is prayed that this Hon'ble Court may be pleased to issue writ order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in issuing GORt No. 145 dated 24-02-2025 against 5th respondent temple to take over management of 5th respondent Temple from the village elders committee of the temple to the Endowment department without any notice as illegal, arbitrary and violative of principles of natural justice and pass such other order or orders as this Hon'ble Court may deem lit and proper in the interest of justice.
11. It is further prayed that this Hon'ble Court may be pleased to suspend the GORt No. 145 dated 24-02-2025 against 5th respondent temple to take over management of 5th respondent Temple pending disposal of the writ petition and pass such other order or orders as this Honble Court may deem lit and proper in the interest of justice.

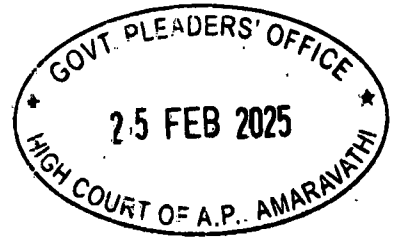
