AFFIDAVIT

I, Chellu Sreenivasa Yadav, S/o.C.Narayana, Aged 48 years, Occ: Hereditary Archaka of Gangamma Devatha Temple, Gollapalli Village, Ananthapuram Revenue, Lakkireddipalli Mandal, Annamayya District, now having temporarily come down to Amaravati, do hereby solemnly and sincerely affirm and state on oath as follows:

1. I am the petitioner/deponent herein as such I am well acquainted with the facts of the case. I may be permitted to submit a few facts for the kind perusal and consideration of this Hon'ble Court.

2. I submit that the present Writ Petition is filed being aggrieved by the action of the Respondent No.7 in handing over the Arachakatvam duties of Gangamma Devatha Temple, Gollapalli Village, Ananthapuram Revenue, Lakkireddipalli Mandal, Annamayya District to the Respondent Nos.8 and 9 in contravention of the register maintained under Section 43 of the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments Act, 1987 and to declare the same as arbitrary, illegal also against Articles 14, 16, 19 and 21 of the Constitution of India and consequentially restrain the respondent Nos.8 and 9

from performing the Archakatvam duties in the 6th respondent temple and the other festivities associated with the temple and to pass such other order or orders as this Hon'ble Court may deem fit and proper in the facts and circumstances of the case.

3. I further submit that the ancestors of the petitioner herein built up the said temple and the family members of the petitioner herein are the founding family members of the temple. It is further submitted that the 6th respondent temple is an ancient temple and the village Goddess or Gramadevatha agama is being followed for worshipping the main deity Sri Gangamma Ammavaru. The said temple had been constructed by our forefathers and the said temple is being developed by our family members from their own funds. It is further submitted that the Sivarathri festivities every year are being conducted and performed regularly with gaiety and pomp for two (2) days by following the custom.

4. It is submitted that from the times immemorial our family members are performing Archakatvam to the said deity under "Pancharathra Aagamamu" with Rikaa!a Poojas and festivities. The Archakatvam rights of the above temple are being got shared among the Chellu family members and the said fact was reflected in the Register maintained under Section 43 of the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments Act, 1987.

5. I further submit that the 6th respondent temple was published under Section 6 of the AP Charitable and Hindu Religious Institutions and Endowments Act, 1987. After publication of the said temple, under Section 6 it comes under the administrative control of the Endowments Department. The said

temple was registered under Section 38 of the Repealed Act, 1966 and also registered under Section 43 of the Amended Act, 1987. The then 5th respondent has approved the said register vide Rc.No.A5/5105/09 dated 13.11.2009.

6. I further submit that after taking over of the 6th respondent temple by the Endowments Department, the 5th respondent appointed my father and two other members of Chellu family as Archakas of the 6th respondent temple and my father's name Chellu Narayana was also shown as Archaka under Section 43(4)(b) along with other Chellu Family members in the register maintained and my father's name was shown at Serial No.2. As per the entries in the said register, the Archakatvam in the temple is being performed by 1) Chellu Ganganna, S/o. Basanna, 2) Chellu Narayana and 3) Adimoolam Chinnappa. It is further submitted that my father was expired on 05-04-2016 and thereafter, I am performing Archakatvam duties in lieu of my father. The copy of Identity card issued in the year 2024 is enclosed herewith for the kind perusal of this Hon'ble Court.

7. I further submit that no salaries were paid to us and in lieu of services rendered as Archakas, we collect sarees and other items offered to the goddess and also get a share in the sale of laddu prasadam. The Archakatvam duties are being rotated among the members of the Chellu family. The male member of the each family will perform Archakatvam for an year by rotation. Performing Archakatvam during the year 2025 was fallen to my share as I am the son of Chellu Narayana having an employee Code No.14045. I further submit that on 30th January of every year the keys of 6th respondent temple, ornaments of goddess will

be handed over to the 7th respondent and founder family members will perform their Archakatvam duties.

8. It is submitted that to our utter surprise, the 7th respondent in collusion with respondent Nos.8 and 9, who are in no way related with the temple affairs were handover with the Archakatvam services. Even though they are not even the permanent residents of Gadda Gundla Rasapalli, Lakkireddypalli Mandal, Annamayya District. They are in no way connected with the temple affairs, except having the same surname Chellu and their father's name is Chellu Ganganna, S/o.Ganganna, but the 7th respondent without issuing any proceedings and behind our back entrusted the Archakatvam duties to the respondent Nos.8 & 9 who happened to be the father and son. Then Chellu Ganganna submitted representation to the respondents bringing to their notice about the illegality committed by the 7th respondent in appointing the Respondent Nos.8 and 9 who are the father and son as Archakas to perform Archakatvam services. The action of the respondent No.7 is arbitrary, illegal against Articles 19, 21, 25 to 28 of the Constitution of India.

9. It is further submitted that Chellu Ganganna and I filed Writ Petitions before this Hon'ble Court in WP.No.4022 of 2025 which was pending before this Hon'ble Court and the WP.No.5334 of 2025 filed by me was withdrawn by me with the liberty to file a fresh Writ Petition. If the respondent Nos.8 and 9 performed Archakatvam duties, we would suffer undue hardship, irreparable loss and grave injury which is nothing but usurping our right contrary to Section 43 Register of AP Charitable and Hindu Religious Institutions and Endowments Act, 1987. Therefore, the present Writ Petition.

10. In the circumstances stated above, the petitioner has no efficacious alternative remedy, except to approach this Hon'ble Court under Article 226 of the Constitution of India. The petitioner has not filed any Writ Petition, Suit or other proceedings for the relief or reliefs sought herein.

11. In these facts and circumstances, it is necessary for this Hon'ble Court to exercise its jurisdiction under Article 226 of the Constitution of India for protection of our fundamental rights guaranteed under the Constitution of India, lest, we will be subjected to irreparable loss, undue hardship and grave injury.

It is therefore prayed that this Hon'ble Court may be pleased to issue appropriate Writ, Order or direction more particularly one in the nature of WRIT OF MANDAMUS by declaring the action of the Respondent No.7 in handing over the Arachakatvam duties of Gangamma Devatha Temple, Gollapalli Village, Ananthapuram Revenue, Lakkireddipalli Mandal, Annamayya District to the Respondent Nos.8 and 9 in contravention of the register maintained under Section 43 of the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments Act, 1987 as arbitrary, illegal also against Articles 14, 16, 19 and 21 of the Constitution of India and consequently restrain/remove the respondent Nos.8 and 9 from performing the Archakatvam duties in the 6th respondent temple and the other festivities associated with the temple and to pass such other order or orders as this Hon'ble Court may deem fit and proper in the facts and circumstances of the case.



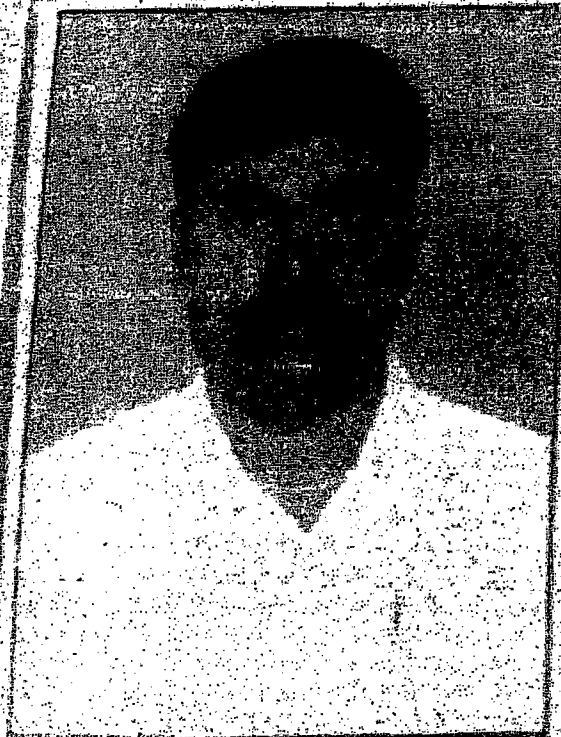

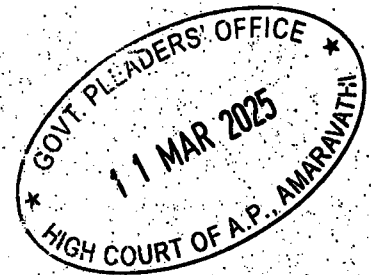
