AFFIDAVIT FILED BY THE PETITIONER

I, Muniratnam Tupakula, S/o Puttaiah, aged about 73 years,
President of Ravuruvari Kandriga Sri Mahalakshmi Ammavari
Devasthanam Abhivruddhi Committee, (Society Reg.no.186 of 2019),
O/o. Girijana Colony, Ravuruvari Kandriga, Orugonda village, Thotapalli
gudur Mandal, SPSR Nellore District., now having temporarily come

down to Amaravathi, do hereby solemnly and sincerely affirm and state as follows:

1. I am the petitioner herein and as such I am well acquainted with facts of the case.
2. I submit that I am filing the present writ petition aggrieved by the action of the respondents no.2 and 3 in not paying the amount as per the bills prepared by the 3rd respondent towards construction of the temple to the petitioner as illegal, arbitrary.
3. I submit that the petitioner was registered on 26-10-2019 under the provisions of Andhra Pradesh Societies Registration Act, 2001 with registration no.186 of 2019. The society was registered with an object to construct Sri Mahalakshmi Ammavari temple at Girijana colony at Ravuruvari Kandriga and to maintain the temple of the Sri Mahalakshmi Ammavaru. The committee of the petitioner has approached the 2nd respondent for the grant of the amount for the construction of the temple. The 2nd respondent vide RC. No. COE/P1/711/2023-18 Dated:17-10-2023 has sanctioned from TTD Srivani Trust Scheme Rs.10,00,000/- to take up the works of construction of Temple. The architect has prepared the design and the petitioner has commenced the construction of the temple under the supervision of Tapathi (Silpi). The petitioner has constructed major works of the temple. The amount of Rs.10,00,000/- sanctioned from the Srivani Trust Scheme to construct the petitioner's temple. The 3rd respondent has prepared bill for an amount of Rs.3,50,000/- and the petitioner has opened a savings bank account in

the Union Bank of India. The 3rd respondent has not issued the cheque for the amount sanctioned as per the bill prepared.

4. I submit that the members of the petitioner's association belongs to the Scheduled Tribe. With the contribution of the amount by the members of the petitioner's committee, the committee has commenced the work and the construction of the temple is at completion stage. The Commissioner has sanctioned an amount of Rs.10,00,000/- for the construction of the temple. The 3rd respondent has approved the bill prepared by the Tapathi (silpi) and prepared the cheque. However, the 3rd respondent has not issued the cheque to the petitioner. The petitioner has incurred huge amount for the construction of the temple. Having sanctioned the amount of Rs.3,50,000/- towards the work executed by the petitioner, there is no justification on the part of the respondents no.2 and 3 in not paying the amount towards the work executed by the committee of the petitioner.

5. I submit that the construction of the temple is at the instance of the petitioner committee. The 2nd respondent has sanctioned the amount for the construction of the temple at Girijana Colony at Ravuruvari Kandriga and entrusted the same to the petitioner's committee. The petitioner's committee was registered under the provisions of the Society Registration Act, 2001 only with an object to construct the temple and to the maintain the temple. Now, the respondents no.2 and 3 are proposed to entrust of the work of the temple to some third party. The idol of Sri Mahalakshmi Ammavaru and the construction of the temple is within the Girijana colony of Ravuruvari Kandriga. The petitioner is entitled to

complete the work. At this stage, if the construction of the work of the temple is allotted to the third party, the petitioner will be put to irreparable loss and prejudice.

6. The petitioner has not filed any other writ, suit or any other proceedings before any competent authority on the subject matter prior to filing of this writ petition in this Hon'ble Court.

7. In the circumstances stated above, the petitioner has no other effective and efficacious alternative remedy except to approach this Hon'ble Court to invoke the Special Original Jurisdiction under Art.226 of the Constitution of India.

8. For the afore said reasons it is prayed that this Hon'ble Court may be pleased to issue a Writ, order or direction more particularly one in the nature of Writ of Mandamus, declaring the action of the respondents no.2 and 3 in not sanctioning the amount towards the construction of the temple and not paying the amount as per the bills as illegal, arbitrary and consequently direct the respondents no.2 and 3 to pay the amount to the extent of the work executed by the petitioner and allow the petitioner to complete the construction work of the Sri Mahalakshmi Ammavari Temple as per the sanction accorded by the 2nd respondent and pass such other or further order or orders as deem fit and proper in the circumstances of the case.

9. It is also prayed that this Hon'ble Court may be pleased to direct the respondents no.2 and 3 to pay the amount as per the bills prepared

for the construction of work of the temple to the petitioner pending disposal of the above writ petition and pass such other order or orders as this Hon'ble Court may deem fit and proper in the circumstances of the case.
