THE HON'BLE SRI JUSTICE VENKATESWARLU NIMMAGADDA

WRIT PETITION No.4237 OF 2023ORDER:-

The present Writ Petition is filed under Article 226 of the Constitution of India, seeking the following relief:

"to issue an appropriate Writ, Order or Direction more particularly a writ in the nature of Writ of Mandamus declaring the action of the 2nd respondent in not considering the case of the petitioner nor appointing the petitioner under Compassionate Quota in the 3rd respondent Temple pursuant to the proposal of the 3rd respondent dt.25.07.2021 as illegal, arbitrary and unconstitutional and consequently direct the 2nd respondent to forthwith consider the case of the petitioner by appointing her in the 3rd respondent temple under compassionate quota and to pass and pass such other order or orders..."

Heard learned counsel for the petitioner, learned Government Pleader for Services-II for respondent Nos. 1 and 2 and Sri K.Madhava Reddy, learned Standing Counsel appearing for respondent No.3.

Learned counsel for the petitioner submits that the petitioner is the wife of the deceased husband, who worked as NMR at the 3rd respondent-temple for a period of thirteen (13) years and died on 02.06.2021 due to COVID while he was in service. After the death of her husband, the petitioner submitted a representation dated 11.10.2022 to the 3rd respondent seeking for compassionate appointment as per the compassionate scheme which is in force at the respondent-temple. Pursuant to the said representation, the 3rd respondent after considering

all the facts and circumstances as well as material submitted by the petitioner and forwarded the said representation of the petitioner along with all the required documents to the 2nd respondent for appropriate orders. Even after receipt of the said recommendation/ representation, the 2nd respondent, who is the competent authority, neither considered nor initiated any proceedings. Hence, the Writ Petition.

On the other hand, learned Standing Counsel for the 3rd respondent submits that since the 3rd respondent already forwarded the representation of the petitioner to the 2nd respondent and since the petitioner is eligible in all respects under compassionate scheme, the representation of the petitioner can be considered by the 2nd respondent in accordance with the rules in vogue, within a reasonable time.

Having regard to the submissions made by the learned counsel for the petitioner, learned Government Pleader for respondent Nos. 1 and 2 and Sri K.Madhava Reddy, learned Standing Counsel appearing for the 3rd respondent, this Court is of the considered view that the present Writ Petition can be disposed of, directing the 2nd respondent to consider the representation/ recommendation dated 25.07.2021 forwarded by the 3rd respondent within a period of two (02) months from the date of receipt of a copy of this order.

Accordingly, the Writ Petition is disposed of. There shall be no order as to costs.

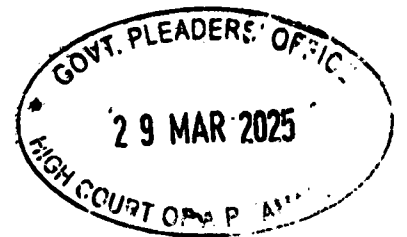
