4. I further submit that the afore said order is well within the respondents knowledge and information as it was pronounced in the presence of Government Pleader, it is binding on them. I got issued Contempt notice dated 06/06/2025 through my council thereby appraising respondents about this hon'ble Court order dated 07/09/2015. Respondents received the same but did not comply with the orders of this Hon'ble court. But the respondents without complying the orders of this Hon'ble court now issue the fresh notification to constitute the Trust Board to the subject temple. The respondent's legal obligation to implement the orders of this Hon'ble court. Even after received the notice dated 06/06/2025 to the respondents and did not communicate there decision on the present issue. Thus the respondents willfully committed acts of contempt by disobeying order of this Hon'ble court. The respondents are liable to be punished for there willful disobedience of order of this Hon'ble court.

AFFIDAVIT FILED ON BEHALF OF THE PETITIONER

I, Podugu Seshavatharam S/o Jagannatha Swamy aged 40 years, resident of Tallur (Village), Gandepally (Mandal), East Godavari District, having temporarily come down to Hyderabad, do hereby solemnly affirm on oath and submit as follows;

01. I submit that I am the Hereditary Trustee of the Petitioner institution and as such, I am well acquainted with the facts of the case.

02. I seek to impugn in this Writ Petition the action of the Respondents in seeking to constitute Trust board to the Sri Venkateshwara Swamy temple (henceforth referred to as 'subject temple') which temple is built in the mutt of the petitioner to cater to the spiritual needs of its inmates, purporting to act under the guise of circular issued by the 2nd respondent Commissioner in reference No. Rc.No.B1/16201/2015-4, dated 6/8/2015, whereby and where under Respondent No. 2 has decided to constitute fresh trust Boards to all the temples in the district of East Godavari district despite there being an express bar for constituting the trust board to the Petitioner's subject temple in Judgement of W.A. No 75/2012, dated 12/01/2012, as being arbitrary and illegal and amounting to showing scant respect to the orders of this Honourable High Court. The material facts which have a bearing the writ petition are set out hereinafter:

03. I submit that the Petitioner is a Mutt and therefore the provisions of the AP Charitable and Hindu Religious Institutions and Endowment Act (hereinafter called 'act' for brevity) cannot be made applicable. Much controversy arose as to be subject temple can be dealt with under the provisions of the Act. Initially the Petitioners have moved the Andhra Pradesh Endowment Tribunal at Kakinada in OA No. 59 of 2011 seeking for a declaration that the provisions of the Act cannot be made applicable to the Petitioner Institution and to the Subject temple which is an integral part of the Mutt.. The final decision has not been made out by the Tribunal on the Lis. However, the Honourable Tribunal by way of interim directions have directed the Endowment Department that the compensation amount already received cannot be spent in any manner which amounts the Dept received illegally, for the lands acquired under the land acquisition, in I.A number 740/2011, on 09/02/2011.

04. It is humbly submitted that despite the dispute is pending in the Endowment tribunal, the respondents herein were bent upon to constitute a trust board to the Sri Venkateshwara Swamy temple of the petitioner and in the year 2011 issued proceedings in Rc.No.A1/11643/2011 dated 22/11/2011, seeking to constitute a trust

board to the subject Temple. The petitioners herein is moved this Honourable High Court in WP No. 34417/2011 along with the said Writ Petition, a WPMP was filed for the grant of stay of Constituting of trust board, however the learned single judge has ordered notice and no stay orders were passed. That in the above circumstances, the petitioners have filed a WA No. 75/2012 in this Honourable High Court. The said Writ Appeal was allowed on 12/01/2012 where under stay was granted insofar as to the Constituting of trust board to the temple, pending WP No. 34417/2011. The Writ Petition is pending as on date and no counter is filed by the Respondents.

05. it is humbly submitted that as the matter stood thus, the second respondent has taken a decision to constitute trust boards to all the temples in the State and instructions were issued on 6/8/2015 in Notice RC No. B1/16201/2015 -4 along with the said notice Annexure insofar as the East Godavari district was appended and pursuant to the above circular trust boards are to be constituted to all 267 temples, district wide. The Petitioners institutions and as well as subject temple was found serial number 56.

06. I humbly submitted that as a matter of fact, in a mechanical way without proper application of mind the Respondents were about to constitute the Trust Board and this fact was made known to me by receipt of Caveat Petition which was filed by the Executive Officer of the group temples and then I made enquiries and also explained to the Respondents that insofar as subject temple is concerned the trust board cannot be constituted in view of the Lis on status of the Petitioner, as pending in O.A. No. 59 of 2011 on the file of the A.P. Endowment Tribunal, Kakinada and also the pendency of the Writ Petition No. 34417/2011, and in the light of the orders passed in Writ Appeal No. 75/2012, dated 12-01-2012. The respondents were reluctant to hear my pleadings and even the court orders are sought to be brushed aside. I got issued a legal notice on 1/9/2010 to the respondents 2 to 5. Apart from sending the notice through registered post a copy of the notice was served directly in the office of 2nd respondent and requested him to instruct the respondents 3 to 5 not to go ahead with the proposed Constituting of the trust board to the petitioner's temple. It was specifically pleaded that there is an express bar by stay granted by this honourable High Court in W.A.No. 75/2012 dated 12/01/2012. The respondents are not

considering my plea and brushed aside my representation and as well as the legal notice and they are bent upon to constitute the Trust Board to the subject temple. In the present writ petition this action of the respondents is questioned, however, the status of the subject temple on the ground the Petitioner is a mutt is not being raised in view of the fact that issue is pending before the Endowment Tribunal at Kakinada. Further Constituting of Trust Board cannot be raised before the Endowment tribunal more so, since the proposed action is in contravention to the stay granted by this Hon'ble High court, the petitioner is constrained to move this honourable High Court again.

07. It is humbly submitted that the proposed action on part of the respondents in seeking to constitute trust board to the subject temple of the petitioner is grossly illegal and contrary to the directions of this Honourable High Court and amounting to showing scant respect to the orders of this Honourable High Court. The provisions of the circular of the Commissioner dated 06-08-2015 in Rc. No. B1/16201/2015-4 cannot be made applicable and enforced upon the subject temple of the Petitioner.

08. In the above circumstances the Petitioner has no other alternative and efficacious remedy except to approach this honourable High Court under Article 226 of the Constitution of India.

09. The Petitioner submits that he has not filed any other writ or suit in any court of law seeking further relief which is now sought in this Writ Petition.

10. In the circumstances, it is prayed that this honourable High Court may be pleased to direct the Respondents not to constitute the trust board to the subject temple Sri Venkateshwara Swamy temple of the Petitioner Mutt at Tallur, Gandepalli Mandal, East Godavari district, as per the Notice of Respondent 2, in Rc.No. B1/16201/2015 - 4, dated 6/8/2015, pending disposal writ petition and pass such other order or orders as deemed fit and proper in the circumstances of the case.

11. That in the above circumstances it is prayed that this Honourable High Court may be pleased to issue an appropriate Writ more in the nature of Writ Of Mandamus declaring the action of the respondents to constitute Trust Board to the Sri
