1. I am the petitioner herein and as such I am well acquainted with the facts of the case.
2. I submit that, the present writ petition is filed questioning the action of the Respondents more particularly Respondent No 7 in handing over archaka duties of the Respondent no.6 temple to the Respondent no. 8 without there being any appointment U/s 35 of the AP Endowments Act and entering his name in the Register U/s 43 of the AP Endowments Act as arbitrary, illegal, violation of Article 14, 19 and 21 of the constitution and Contrary to the procedure envisaged under the A.P. and consequently direct the respondents to handover the archaka duties to the petitioner herein.
3. I submit that, the 6th respondent Temple is an ancient temple and the Gramadevatha agama is being followed for worshiping the main deity Sri Gangamma Ammavaaru. The said temple had been constructed by our family members in their lifetime and thereafter. Thereafter, the said temple is being

The archakatvam of the said deity continued under the 'Pancharathra Aagamamu' with Trikaala Poojas and festivals. The Achakatvam rights of the temple got shared among the Chellu family members.

4. I submit that, the 7th respondent temple was published U/s. 6 of the the act, 1987 and the same is under the administrative control of the Endowment Department. The said temple was registered U/s. 38 of the repealed Act, 1966 and also registered U/s. 43 of the Act, 1987. The 5th respondent has approved the said register vide Rc.No.A5/5105/09, dated 13.11.2009.

5. I submit that, after taking over the 6th respondent temple by the Endowment department, the 5th respondent issued the proceedings in Rc.No.A5/5105/09, dated 13.11.2009 appointing me and two members of Chellu family as Archakas of 6th respondent temple and our names had also been entered in the Section 43 Register. As per the entries in the said registers, the archakatvam in the temple is being rendered by the 1. Chellu Ganganna S/o. Basanna (Writ Petitioner herein) 2. Chellu Narayana 3. Adimoolam Chinnappa were rendering archaka service on rotation basis every year. It is pertinent to submit herein that, as per the Old Register approved U/s 38 of the old repealed act, 1966, the petitioners' father Late Chellu Basanna alias Obanna used to perform archakatvam.

I submit that, 30th January of every year the keys of the 6th respondent temple, ornaments of goddess will be handed over to the 7th respondent and the 7th respondent in turn handovers the same to the person next in line. That Chellu Narayana Family members performed their duties for the year 2024 and handed over their responsibilities on 30th Jan, 2025. The 7th respondent with a malafide intention and in collusion with the 8th respondent, instead of handing over the keys and duties to the petitioner herein who is next in line, trying to handover the duties of archakatvam to the 8th respondent, without there being any appointment U/s 35 of the Act, 1987. The 8th respondent is not an employee and his name is not mentioned in the Endowment register. It is also pertinent to

submit herein that the 8th respondent is working as police constable, Intelligence wing at Galivedu Police station, Annamayya District (HC No. 537).

8. I submit that, as per the records available with the respondent no. 2 to 5 and also as per the entries in Section 43 Register, I am performing one third share of archakatvam rights on rotation basis. The 6th respondent temple is going to conduct festival on 28th February, 2025. I also submitted representation dated 02.02.2025 to the 2nd to 5th respondents. The 5th respondent vide proceedings Memo.No. A2/18/2025 dated 04.02.2025 directed the 7th respondent to act in accordance with the procedure. No action was taken by the 7th respondent. Hence, if any interim order is not granted the petitioner will be put to irreparable loss and hardship.

9. That I have no other alternative and efficacious remedy except to approach this Hon'ble Court under Article 226 of the Constitution of India.

10. That I have not filed any petition seeking the relief claimed hereunder and no petition is pending before any Court or authority in this regard.

For the reasons stated above, it is therefore prayed that this Hon'ble Court may be pleased to issue Writ of Direction more particularly in the nature of Writ of Mandamus declaring the action of the respondents more particularly 7th respondent in handing over archaka duties of the 6th respondent temple to



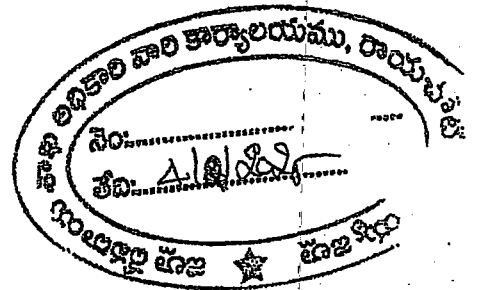

Sir, just to let you know, the annual Brahmotsavam for Amma is held for three days every year starting from the day after Mahashivratri. This year it will be held from February 28, 2025 to 1st and 2nd March.

Regarding this matter, we would like to ask for your opinion, Head constable, HC, 537, Galiveedu Police Station, Lucky Reddy Palli, Annamaiya District, Andhra Pradesh. I strongly pray that to handed over to me, and to see that the Executive Officer, Sri Sri Anantapuram Gangamma Goddess Devasthanam will be ordered and to see that the Brahmotsavams are conducted smoothly.





permitting the respondents No.3 and 4 to enter the names of the respondent No.8 and six 6 others in Section 43 Register of the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments Act, 1987 without crystallising their share of Archakatvam rights as per the records available with them and the consequential proceedings in Lr.No.A2/15/20222, dated 21.05.2022 issued by the respondent No.4 in ordering inclusion of their names in Section 43 Register after finalization of the proceedings pending adjudication on the file of the Endowments Tribunal and this Hon'ble Court as arbitrary and illegal. This writ petition is not maintainable either on facts or under law.

4) It is submitted that 7th respondent temple was published U/Sec.6(a)(ii) of the Act, 1987 and the same is under the administrative control of 3rd respondent. The said temple is under the management of an Executive Officer, who is appointed U/Sec.29 of the Act by the 2nd respondent. The said temple was registered U/Sec.38 of the repealed Act and also registered U/Sec.43 of the present Act, 30/87. As per the entries in the said registers, 7th respondent temple i.e., Sri Gangamma Devatha Devasthanam, Anathapuram Village, Lakkireddipalle mandal is an ancient temple and the Gramadevatha

agama is being followed for worshipping the main deity Sri Gangamma Ammavaaru. The Archakatvam in the temple is being rendered by the family members of CHELLU (the name of Chellu Obenna was found in the register U/Sec.38 of Old Act). As per the records available, the said family consisting of three persons i.e., Chellu Ganganna S/o Basanna 2. Chellu Narayana (died) and 3. Adimoolam Chinnappa (Writ Petitioner) were rendering Archaka service on rotation basis every year. This respondent is not aware whether Chellu family members had executed Karanama Dt:20-2-1939 in favour of Nagamma allotting one third Archaka share and also the Karanama Dt:12-03-1948 bequeathing her share in favour of the petitioner. Hence, the petitioner is put to strict proof of the same. However, there will be no sanctity at all for such agreement, as per the provisions of the Act.

5) It is further submitted that as per approved Statutory Register of 7th responded temple U/Sec.43 of the Act, Chellu Ganganna, S/o. Basanna, Chellu Narayana, S/o. Venkataiah and Adimulam Chinnappa (petitioner herein) are working as hereditary archakas on rotation basis year wise. Out of three hereditary archakas, Chellu Narayana is no more. In the place of deceased Chellu Narayana 6 persons including Chellu Ramachandra, S/o. Late Narayana



have been attending Archakatvam in 7th respondent temple along with two other hereditary families on rotation basis. The names of 6 persons including Chellu Ramachandra are entered in the register U/Sec.43 (10) of the Act in the place of Chellu Narayana, after conducting enquiry by the District Endowments Officer, Endowments Department, Annamayya District. Therefore, no prejudice would be caused to the petitioner herein by inclusion of the name of those persons as the petitioner also can render Archakatvam in the 7th respondent temple as and when his turn comes on rotation basis year-wise i.e. to the hereditary family of "Adimulam". No cause of action arose to the petitioner to file this writ petition by invoking Article 226 of the Constitution of India.

6) It is farther submitted that the 7th respondent has submitted a report in Rc.No.15/2021, dated 28.09.2021 to the 3rd respondent and submitted its copy to the 2nd respondent. On considering the report of 7th respondent dated 28.09.2021, the 2nd respondent in his proceedings in Rc.No.C1/13024/2/2021, dated 04.12.2021 has accorded permission to the 7th respondent to enter the names of archakas in Sec.43(10) register. Later, the 7th respondent has prepared register U/Sec.43(10) of the Act and submitted it to the 5th respondent, who in turn examined the entries in Sec.43(10) register of 7th respondent temple and

approved vide proceedings in R.Dis.No.A2/15/2022, dated 21.05.2022 by entering 6 names in the place of deceased hereditary archaka Chellu Narayana as explained above. Thereby those 6 persons including son of Narayana are stepped into the shoes of late Chellu Narayana to attend Archakatvam in 7th respondent temple on rotation basis along with other two hereditary archaka families i.e. petitioner herein and Chellu Ganganna, S/o. Basanna. Sub-section(10) of Section 43 of the Act authorizes the Executive Authority of the Temple to report to the Assistant Commissioner the alternations, omissions or additions in the particulars, relating to the Institution or Endowment. Thereupon the Assistant Commissioner shall make such enquiry as he deems fit and amend the certificate where ever necessary and return it to the Executive Authority. In pursuance of sub-sec(10) of Section 43 of the Act, the 7th respondent has submitted a detailed report to enter names of six persons in the place of deceased Chellu Narayana an hereditary archaka of 7th respondent temple. Accordingly, the 5th respondent after making enquiry, certified register U/Sec.43(10) of the Act. Thus, Sec.43 Register of the 7th respondent temple was modified on 21.05.2022. By virtue of it, names of six persons are entered in the place of hereditary family of deceased Chellu Narayana.

7) It is further submitted that as per sub-section (1) of Section 45 of the Act any person aggrieved by an entry or omission to make an entry in the register maintained U/Sec.43 may apply to the Endowments Tribunal for modification or annulment of such entry, or for directing the making of such entry, as the case may be. Therefore, the petitioner herein in case he is aggrieved by the entry of names of six persons regarding hereditary archaka family of Late Chellu Narayana in Sec.43 register of 7th respondent temple, he has a statutory remedy to approach A.P. Endowments Tribunal for redressal but the petitioner cannot invoke Jurisdiction of this Hon'ble Court directly under Art.226 of Constitution of India. It is settled law that a writ petition is not maintainable, when an alternative and efficacious statutory remedy is available under the Statute. On this ground alone, this writ petition is liable to be dismissed in limine.

8) It is further submitted that this writ petition is bad for non joinder of proper and necessary parties as the petitioner did not add six persons, whose names were entered in the register U/Sec.43 (10) of the Act as respondents in this case. In the absence of the said six individuals as respondents in the present writ petition, the issue involved in this case may not be finalized conclusively and effectively. Therefore, this writ petition is liable to be dismissed for non joinder of proper and necessary parties.





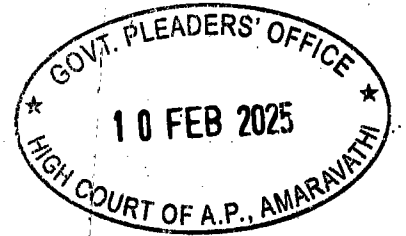
